


- Users should not attempt to disassemble the camera. There are no user serviceable parts inside. Ask qualified service personnel for servicing.
- Do not use strong solvents or detergents. Use a dry cloth on the camera when it is dirty.
- Before operating, please check proper temperature, humidity and power source ratings.
- Do not aim the camera at bright objects or place it in direct sunlight. This may result in blooming or smearing.

FUNCTIONS

The camera includes auto white balance mode (AWB) and color temperature. The range is 2400° K $^{\sim}9600^{\circ}$ K


SENSOR

Auto Cell Device Sensor, the IR LED automatically turns on when exterior illumination drops below pre-set levels. IR LED will not activate when exterior illumination is above pre-set levels, to reduce power consumption. Illumination is 2.6 lux (LED on) / 2.7 lux (LED off)




LENS

DC JACK is for power in. 12vdc required. (not supplied)

ZOOM


Adjust varifocal lens if object is out of focus.

FOCUS

Focus adjustment available if object is out of focus.

INSTALLATION

- 1. Attach camera to bracket.
- 2. Connect the 75Ω coaxial cable to device video input.
- 3. Connect power cable.
- Adjust camera to cover the desired field of view
 Note: The camera is supplied with the focus pre-set, however, lens focus may be adjusted if needed.
