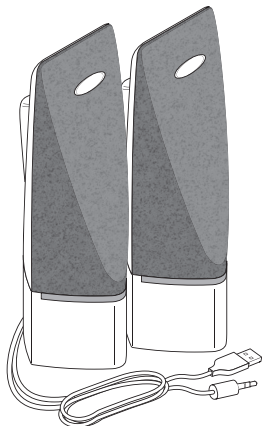

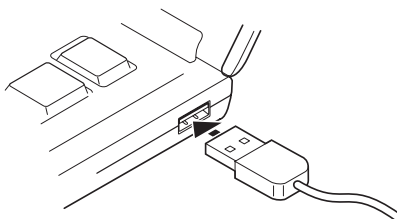

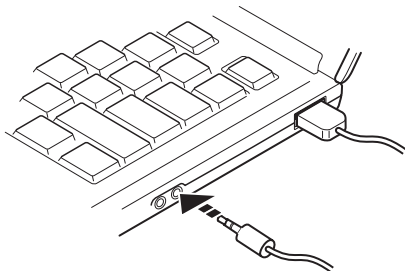
- Available 3.5mm audio out (headphone jack)

Plug the USB cable into an available USB port on the computer. USB ports are identified as .

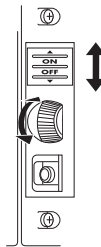
