Installation

- 1. Rotate power plug to the open position.
- 2. Plug the 4.2A USB Power Adapter 2-Port into any 110V-240V wall outlet.
- 3. Verify the LED power indicator is lit.
- 4. Plug the factory USB charging cable or other USB power cable into an available USB power port to charge device(s).
