



1 Installation


IMPORTANT NOTE: The device must be professionally installed and must use the supplied antennae.

The unit is designed for outdoor use and may be attached to either a pole or wall. A waterproof connector is supplied to ensure a watertight seal for connecting the Ethernet cable to the device.


Note: The device can be mounted either outdoors or indoors. The included PoE injector and surge protector must be mounted indoors, as they are not weatherproof.

To mount the device on a wall

- Using the wall-mount base as a template, mark the location of the mounting bolt holes on a flat wall surface.
- 2. Drill the mounting holes in the marked locations.
- 3. Fasten the wall-mount base securely to the back of the unit using the provided mounting screws.




4. Attach the unit and base assembly to the wall using the provided concrete mounting bolts.




5. Securely tighten the mounting bolts.

To mount the FortiAP unit on a pole


- 1. Fasten the wall-mount base securely to the back of the unit using the provided mounting screws.
- 2. Attach the pole-mount bracket to the wall-mount base using with the provided screws.



The pole-mount bracket can be attached either vertically or horizontally, as required.



3. Loop the provided pole strap through the slots on the pole-mount bracket and then around the pole.



4. Tighten the strap with an appropriate screw driver and ensure that the device is firmly in place.

A Antennae

The FortiAP 222C unit provides dual concurrent radio signals. Use the top antenna mounts to access the Radio 1 (802.11 b/g/n at 300Mbps) signals, and the bottom antenna mounts (near the waterproof PoE connector) to access the Radio 2 (802.11 a/n/ac at 867Mbps) signals. To use both radio frequencies concurrently, use all four WiFi antennae.

To Install the WiFi antennae

- 1. Insert the antenna base firmly into the appropriate antenna mount.
- 2. Securely hand tighten the fastening collar.
- 3. Repeat for the remaining antennae.







The unit requires 48V DC power, which is delivered by the PoE injector, through the surge protector, over a straight-through Ethernet cable.

To install the weatherproof connector

1. Unscrew the coupling ring from the waterproof connector, remove the sealing gland, and thread the RJ-45 plug through the connector components.



- 2. Insert the RJ-45 plug into the PoE port on the unit and install the weatherproof panel connector onto the threaded coupling at the port.
- 3. Slide the sealing gland along the cable into panel connector.



4. Thread the coupling ring onto the panel connector and tighten it until the sealing gland is compressed, making a watertight seal on the cable.



2 Connections

Adequate grounding must be provided to the FortiAP unit, the PoE injector, and the surge protector; grounding lugs and cables are provided for this purpose. Consult a certified electrician to ensure that all grounding and cabling is installed in compliance with the local electrical code.


Use an exterior-grade or direct burial CAT5 Ethernet cable for connecting the outdoor unit to the surge protector. Use the supplied weatherproof connector to ensure a tight seal at the PoE port on the unit.


Note: The PoE injector and surge protector units are not weatherproof and must be mounted indoors. They should be mounted as close together as possible.

Caution: Do not connect the PoE injector to a PoE enabled Ethernet port.

To wire the surge protector

- 1. Remove the cover of the surge protector using an appropriate screwdriver.
- Connect the ground wire with the spade lug connector to the grounding post between the two ethernet connectors.
- Connect the straight-through Ethernet cable that will connect to the FortiAP unit to the Ethernet port on the right side of the surge protector.
- Connect the straight-through Ethernet cable that will connect to the PoE injector the Ethernet port on the left side of the surge protector.
- Ensure that the cables comfortably pass through the provided slots on the front of the surge protector.
- 6. Replace the cover onto the surge protector using an appropriate screwdriver.






To Connect the FortiAP unit

- Connect grounding cables to the grounding lugs on both FortiAP unit (bottom middle of unit) and the PoE injector, then connect the other ends of the cables to appropriate ground connections.
- 2. Connect the surge protector's grounding cable to an appropriate ground connection.
- 3. Connect the region-specific AC plug adapter to the AC power adapter by inserting the round disk into the adapter and rotating clockwise until you hear the disk lock in place.
- 4. Insert the DC plug of the power adapter into the DC IN port on the PoE injector, then plug the AC adapter into an appropriate power outlet. The PWR LED will light up.
- Connect one end of a cross-over Ethernet cable to the Network port on the PoE
 injector. Connect the other end to the FortiGate controller or an Internet connection.
 Do not connect the PoE injector to a PoE enabled Ethernet port.
- 6. Using the supplied weatherproof connector, connect the weatherproof, straight-through Ethernet cable on the right side of the surge protector to the PoE port on the bottom of the FortiAP unit, as described in "Cabling" on page 9.
- 7. Connect the straight-through Ethernet cable on the left side of the surge protector into the AP/Bridge port on the PoE injector.




A FortiCloud

- 1. Visit http://www.forticloud.com and sign in or create a new account.
- Click the "Add Device" link, enter the unique FortiCloud key located on your FortiAP device, then click Submit.



Deploy the FortiAP to an existing AP network, or create a new AP network, then click Submit.



- 4. Follow the prompts to associate the FortiAP device to an SSID.
- 5. Connect your FortiAP to an Internet connection. This can be a modem or another source of Internet connectivity. The FortiAP will self-configure.

B Deployment through a FortiGate

If your FortiGate is on the same network as your FortiAP:

- Preauthorize your FortiAP device using your FortiGate. If you are not familiar with deploying a FortiAP using your FortiGate, refer to the "Access Point Deployment" section of the Deploying Wireless Networks Guide found at http://docs.fortinet.com.
- 2. Plug your FortiAP into your local Ethernet connection. The FortiAP will self-configure.

Or

- 1. Instead of preauthorizing, you can authorize your FortiAP via the FortiGate after you have connected the FortiAP to your local Ethernet.
- 2. Within two minutes of connecting the FortiAP to your FortiGate, the device will appear on the Managed FortiAP page in the Web-based Manager: authorize the device and assign a profile to the device.



If your FortiGate is not on the same network as your FortiAP:


- 1. Log in to the FortiAP directly (IP address: 192.168.1.2) with username admin and no password, and specify the IP address of the controlling FortiGate.
- 2. Connect to the FortiAP via the CLI using the instructions in the "Connecting to FortiAP CLI" section of the Deploying Wireless Networks guide.
- 3. Specify the IP address of the controlling FortiGate:



where 0.0.0.0 is the address of the FortiGate.


4. The FortiAP will connect to the FortiGate, and then you can authorize the FortiAP.
