- Support three main HD formats: VC-1, H.264, MPEG-2 and many other normal formats such as MPEG-1, MPEG-2, MPEG-4, DIVX, REALMEDIA and so on.
- Video formats include avi, mpg, vob, rmvb, mkv, m2ts, tx, and so on.
- Photo formats include JPEG, BMP, and PNG up to 80M pixels.
- Audio formats include MP3, WMA, AC3, DTS, AAC, and so on.
- Support SD/SDHC/MMC cards.
- Support two USB 2.0 host connectors with maximum output current of 1.5A/5V.
- Support standard RJ45 cable network connection and wireless network connection.
- Support infrared remote control operation.




# Remote Control



Remote key	Description
	<b>Power:</b> Click to turn on/off.
	<b>SET:</b> Not functional on this model.
	<b>TV IN:</b> Not functional on this model.
	<b>SETUP:</b> Click to access the Settings options.
	<b>APP:</b> Not functional on this model.
	<b>VOL:</b> Click to decrease/increase the volume.
	<b>Home:</b> Click to get back the main menu.
	<b>Return:</b> Click to return back to previous menu.
	<b>Navigation:</b> Click to navigate left/right/up/down, and click OK to confirm your selection.


	<p><b>Menu:</b> Click to choose function menu of corresponding application in video, music, photo and website.</p>
	<p><b>Mouse:</b> Click to use the navigation button as a mouse.</p>
	<p><b>Number:</b> Click to select a number.</p>
	<p><b>Mute:</b> Click to turn down the volume.</p>
	<p><b>Backspace:</b> Click to backspace the input.</p>

## Mounting

If desired, the Android module can be mounted to the back of the display. To do so, attach the velcro strips onto back of module per the illustration. Then attach it to the back of display being careful not to block display vents.




Note: When mounted to the back of the display, we recommend using the display to control the Android module instead of the remote.

## Startup

Turn on the InFocus Android module when the indicator light is blue. The main menu appears in about 30 seconds.

# Home


From the home page, you can access a number of features using the shortcuts at the bottom of the screen.

This is where all installed applications and widgets can be accessed.


Note: InFocus only supports the Whiteboard application. InFocus does not design or support any other Android applications and widgets. Android applications and those found in the Play Store are supported by their associated manufacturers.



- 1) Navigate to **My Apps**.
- 2) Click **OK**.
- 3) Navigate to the desired application.

# Whiteboard

Use the Whiteboard to brainstorm ideas, create graphs, and work-flows, or whatever you desire. This blank slate lets you collaborate, share, and save your ideas.



## Create a drawing

- 1) Tap a drawing object from the Tools submenu.
- 2) Tap the color, size, and opacity you desire.
- 3) Draw on the whiteboard canvas with your finger or a stylus.  
**TIP:** Keep other objects, including writing utensils, other fingers, and knuckles away from the drawing surface to draw your image cleanly.
- 4) Use **Erase**, **Select**, **Undo**, and **Re-do** to modify the drawing.

## Add text

- 1) Tap **Text** in the Tools submenu
- 2) Tap the screen where you want the text box to be. A text box opens.
- 3) Adjust the font family, type, size, and color, as desired.
- 4) Using either a keyboard or the on-screen keyboard, type your text.
- 5) Tap **OK** when finished.
- 6) Tap and drag the text box to the desired position.

## Import an image

Supported image types include JPEG, PNG, BMP, GIF, and TIFF.

- 1) Tap **More**.
- 2) Tap **Import**.
- 3) By default, the device will look at internal storage. To import the image from a USB thumb drive, tap the **USB** icon.
- 4) Navigate to the associated folder and tap the desired image.
- 5) Tap **Done**.
- 6) While the object is highlighted, drag it to the desired location and re-size it as needed using the sizing handles. In addition, you can cut, copy, paste, and delete it using the features in the Select submenu.
- 7) Tap **Cancel** when finished.

## Modify objects



- 1) Tap **Select**.
- 2) Tap and drag your finger or the stylus across the objects you would like to select. The objects are outlined.

**To copy the selected objects:** tap **Copy** and tap **Paste**. While the objects are selected, drag them to the desired location.

**To cut the objects and place them on a different page of the whiteboard canvas:** tap **Cut**. Then navigate to the desired page and tap **More** and **Paste**. While the objects are selected, drag them to the desired location.

**To delete the objects:** tap **Delete**. The objects are deleted immediately.

## Navigate the whiteboard canvas

- 1) Tap **Next**  to add or go to the next page.
- 2) Tap **Previous**  to add or go to the previous page.

**Note:** The whiteboard feature supports up to 9 pages total. You can grow the canvas, but you cannot shrink the canvas.

- 3) Tap the **Canvas** tool to navigate between pages.
  - a. Tapping an arrow within the Canvas tool moves the current view 1/2 page in the direction of the arrow. If the arrow is gray, you have reached the maximum edge of the canvas.
  - b. Tap any cell in the map to move directly to that page.

## Clear the canvas

Tap **Clear** to remove all whiteboard data from the entire whiteboard canvas.

## Save the whiteboard canvas

- 1) Tap **More**.
- 2) Tap **Save** to save it to the unit, or tap **USB** to save it to a USB thumb drive.
- 3) Type a file name in the **Name** text box.
- 4) Select the file type:

File Type Option	Choose this file type if you want to...
DigiEasel	saves the whiteboard file for future editing.
JPG	creates an image file. <b>Note:</b> The image file cannot be re-opened by the monitor for later use.
PDF	creates a printable document for others to view. <b>Note:</b> The PDF file cannot be re-opened by the monitor for later use.

- 5) For JPG and PDF file types, tap **Current view** to save the visible portion of the canvas or tap **Whole view** to save the entire canvas. **Note: Whole view** creates multiple pages and requires extra time to complete.
- 6) Enter the desired file location or accept the default location.
- 7) Tap **Save**.

## Open a new whiteboard canvas

- 1) Tap **More**.
- 2) Tap **New**.
- 3) Then select **Save** to save the current canvas or select **Don't save** to delete the current canvas and open a new one. **Cancel** returns the user to the current canvas.







## Open a saved whiteboard canvas









The following instructions explain how to open a saved DigiEasel whiteboard file. To open a saved JPG or PDF file, navigate to File-Browser.




**Note:** JPG files can be opened with Gallery or Kodi applications. PDF files require a PDF reader (not included in the standard application set).


- 1) Tap **More**.
- 2) Tap **Open**.
- 3) If the current whiteboard canvas contains objects, you will be prompted to save the current canvas. Select **Save** to save the current canvas or select **Don't save** to delete the current canvas and open a new one. (**Cancel** returns the user to the current canvas.)
- 4) By default, the **Open Files** window displays whiteboard files saved internally on the monitor. To open a saved file from a USB thumb drive, tap the **USB** icon at the top of the Open Files window, and navigate to the desired USB thumb drive.
- 5) Navigate to the desired folder and tap the file you wish to open.




## Whiteboard tools



Icon	Tool Name	Description
 Previous	Previous	Tap to go to the previous page.
 Pen	Current tool	Tap to use the current tool.
 Eraser	Eraser	Tap <b>Eraser</b> , and then tap and drag across the drawing object to erase the portion you touched.
 Color Wheel	Color Wheel submenu	Tap to access the color sub-menu.
	Color wheel	Tap to choose a color using a color ramp. The current selected color appears in the middle of the color wheel.
	Segmented color wheel	Tap to choose a color from the segmented color wheel. The current selected color appears in the middle of the color wheel.

 Size	Size	Tap and drag the thumbnail button along the slider path to adjust the size of the pen/line width.
 Opacity	Opacity	Tap and drag the thumbnail button along the slider path to adjust the size of the highlighter/shape opacity.
 Tools	Tools submenu	Tap to select a drawing object. <b>NOTE:</b> Each object has its own color, pen width, and pen transparency setting.
 Pen	Pen	Tap to use a pen. <b>NOTE:</b> Opacity control is not available for the pen object.
 Highlighter	Highlighter	Tap to use a highlighter.
 Rectangle	Rectangle	Tap to draw a rectangle.
 Circle	Circle	Tap to draw a circle.
 Line	Line	Tap to draw a line.

	Text	<p>Tap <b>Text</b>. Then tap the existing text object, or another area on the screen where you want a new text box to be placed, and adjust the placement, font size, color, and type attributes as desired. Type your text and tap <b>OK</b>.</p>
	Laser	<p>Tap to highlight something temporarily. The red laser mark disappears when a new mark is made. Laser marks cannot be saved.</p>
	Select	<p>Tap <b>Select</b>. Tap and drag the selection box around the drawing objects which you want to move, copy or delete.</p> <p>Tap and drag the selected objects to move them.</p> <p>Tap <b>Copy</b> to copy or <b>Delete</b> to delete the selected drawing objects. <b>Cancel</b> removes the selection. <b>TIP:</b> Copied objects are laid directly on top of existing drawing objects. Tap and drag the copied annotation mark to a new location.</p>

 Cut	Cut	Tap to cut the selected object(s).
 Copy	Copy	Tap to copy the selected object(s).
 Paste	Paste	Tap to paste the last copied or cut object(s) onto the whiteboard canvas.
 Delete	Delete	Tap to delete the selected object(s).
 Cancel	Cancel	Tap to remove the selection box.
 Undo	Undo	Tap to reverse the last executed command.
 Redo	Redo	Tap to reverse the last Undo command.
 Clear	Clear	Tap to clear the drawing objects from the whiteboard canvas.

	More submenu	Tap to access additional menu features.
	Canvas	Tap to open the canvas tool, which allows you to navigate between pages.
	New	Tap to open a new whiteboard canvas.
	Open	Tap to open a saved file.
	Save	Tap to save the file as a JPG image or PDF file.
	Paste	Tap to paste the last copied or cut object(s) on the whiteboard canvas.
	Import	Tap to import an image onto the whiteboard canvas. To remove an imported image, tap the red <b>X</b> in the top right-hand corner of the image.

 <p>USB</p>	USB	Tap to save or open files from an external USB thumb drive.
 <p>Next</p>	Next	Tap to go to the next page.

# Settings

To access the settings options, click the **Settings** shortcut (or to **My Apps > Settings**).

## Network

### Wi-Fi




- 1) If the Wi-Fi check box is checked, the system scans for available Wi-Fi networks automatically.
- 2) Click **OK** to choose your Wi-Fi network and enter with your password.
- 3) After authenticating the IP address, when connected is shown, Wi-Fi is available.

**Note:** Sometimes Wi-Fi is unstable. If the WiFi connection fails, please try again.

## Ethernet

If the Ethernet check box is checked, the system scans for Ethernet connections automatically.



## Display



- 1) Navigate to **Settings > Display**.
- 2) You can select the HDMI audio output mode, turn the status bar on or off, adjust the display position, and choose the screen saver start time.

## Advanced



- 1) Navigate to **Settings > Advanced**.
- 2) You can control the remote control, Google TV Remote, CEC control, orientation, and digital audio output.

## Other



Navigate to **Settings > Other** to see more InFocus Android module information. You can also update firmware and change other settings here.

## Troubleshooting

Under no circumstances should you try to repair the InFocus Android module by yourself, as this will invalidate the warranty. Do not open the InFocus Android module as there is a risk of electrical shock. If a fault occurs, first check with points listed below before taking the InFocus Android module for repair. No image	<ul style="list-style-type: none"><li>• Reconnect the HDMI cable or AV cable.</li><li>• Verify that the InFocus touch display is turned on.</li></ul>
No sound or distorted sound	<ul style="list-style-type: none"><li>• Adjust the volume.</li><li>• Verify that the HDMI cable or audio cable is properly connected to the InFocus Android module and to the InFocus touch display.</li><li>• Verify that the speakers are connected correctly.</li></ul>

No audio or digital output	<ul style="list-style-type: none"> <li>• Check the digital connections.</li> <li>• Verify that your amplifier is set correctly.</li> </ul>
No sound during movie playback	<ul style="list-style-type: none"> <li>• Adjust the volume.</li> <li>• The audio codec may not be supported by the InFocus Android module. Change the audio codec.</li> </ul>
The box does not respond to the remote control	<ul style="list-style-type: none"> <li>• Aim the remote control directly at the sensor on the front of the InFocus Android module.</li> <li>• Reduce the distance to the InFocus Android module.</li> <li>• Replace the batteries in the remote control.</li> </ul>

# Limited Warranty

## InFocus Limited Warranty For InFocus Branded Hardware Products Only

**LIMITED WARRANTY.** InFocus's warranty obligations for the hardware products are limited to the terms set forth herein. InFocus warrants the InFocus-branded hardware products against defects in materials and workmanship under normal use for a period outlined in the Limited Warranty Periods section below from the date of retail purchase by the original end-user purchaser ("Warranty Period"). The Warranty Period starts on the date of purchase. Your dated sales or delivery receipt, showing the date of purchase of the product, is your proof of the purchase date. You may be required to provide proof of purchase and proof that the product was purchased new as a condition of receiving warranty service.
