



#### **Features**

#### **Front view**





#### (I) Power button

The power button allows you to turn the Chromebox on or off. You can use the power button to put your Chromebox to sleep mode or press it for four (4) seconds to force shutdown your Chromebox.



#### Headphone/Headset/Microphone jack

This port allows you to connect amplified speakers or headphones. You can also use this port to connect your headset or an external microphone.



**NOTE:** This port may vary per model.

#### USB 3.2 Gen 2 port (on selected models)

The USB 3.2 Gen 2 (Universal Serial Bus) port provides a transfer rate up to 10 Gbit/s. These ports also support the Battery Charging 1.2 technology that allows you to charge your USB devices.

#### USB 3.2 Gen 1 port (on selected models)



This recovery button hole allows you to reset your Commercial Chromebox to factory settings. Insert a pin or paperclip into this hole, then press and hold the recovery button for at least three (3) seconds to reset your Chromebox to factory settings.

This slot allows you to attach the cable organizer.

The supplied power adapter converts AC power to DC power for use with this jack. Power supplied through this jack supplies power to the Commercial Chromebox. To prevent damage to the Commercial Chromebox, always use the supplied power adapter.

Serial port (COM/RJ-50)


#### **Getting started**

## Connect the AC power adapter to your Commercial Chromebox

To connect the AC power adapter to your Commercial Chromebox:

- A. Connect the power cord to the AC power adapter.
- Connect the DC power connector into your Commercial Chromebox's power (DC) input.
- C. Plug the AC power adapter into a 100V~240V power source.

**NOTE:** The power adapter may vary in appearance, depending on models and your region.



#### IMPORTANT!

- We strongly recommend that you use only the AC power adapter and cable that came with your Commercial Chromebox.
- We strongly recommend that you use a grounded wall socket while using your Commercial Chromebox.
- The socket outlet must be easily accessible and near your Commercial Chromebox.
- To disconnect your Commercial Chromebox from its main power supply, unplug your Commercial Chromebox from the power socket.




#### To connect a display panel to your Commercial Chromebox:

Connect one end of a HDMI<sup>™</sup> or USB Type-C° cable to an external display, and the other end of the cable to your Commercial Chromebox's HDMI<sup>™</sup> port or USB 3.2 Gen 1 Type-C°/DisplayPort combo port.

#### Connect display via USB 3.2 Gen 1 Type-C\*/DisplayPort combo port




#### **Connect the USB cable from keyboard or mouse**

You can connect generally any USB keyboard and mouse to your Commercial Chromebox. You can also connect a USB dongle for a wireless keyboard and mouse set.

#### To connect a keyboard and mouse to your Commercial Chromebox:


Connect the USB cable from your keyboard and mouse to any of the USB ports of your Commercial Chromebox.

**NOTE:** The keyboard varies with country or region.




#### **Turn on your Commercial Chromebox**

Press the power button to turn on your Commercial Chromebox.



## (optional) Installing the wall mount to your device

- Turn off your Commercial Chromebox then disconnect all cables and peripherals.
- Place the Commercial Chromebox on a flat surface, with its top side facing down.
- 3. Remove the four (4) screws and rubber feet from the bottom of the device.




4. Prepare your wall mounts.

- Place the wall mount on the bottom of your Commercial Chromebox, making sure the screw holes are all aligned.
- 6. Secure the wall mount using the four (4) screws you removed earlier.



Ensure to remove the rubber feet from the screws before using them to secure the wall mount.





**Appendix** 

#### Safety information

Your Commercial Chromebox is designed and tested to meet the latest standards of safety for information technology equipment. However, to ensure your safety, it is important that you read the following safety instructions.

#### Setting up your system

- Read and follow all instructions in the documentation before you operate your system.
- Do not use this product near water or a heated source.
- Set up the system on a stable surface.
- Openings on the chassis are for ventilation. Do not block or cover these openings. Make sure you leave plenty of space around the system for ventilation. Never insert objects of any kind into the ventilation openings.
