Your Chromebook can get warm to hot while in use or while charging the battery pack. Do not leave your Chromebook on your lap or near any part of your body to prevent injury from heat. When working on your Chromebook, do not place it on surfaces that can block the vents.



Do not use damaged power cords, accessories, and other peripherals with your Chromebook.



While powered on, ensure that you do not carry or cover your Chromebook with any materials that can reduce air circulation.

### **Caring for your Chromebook**



Disconnect the AC power and remove the battery pack (if applicable) before cleaning your Chromebook. Use a clean cellulose sponge or chamois cloth dampened with a solution of nonabrasive detergent and a few drops of warm water. Remove any extra moisture from your Chromebook using a dry cloth. Keep any liquids from entering the chassis or keyboard gap to prevent short circuit or corrosion.



Do not use strong solvents such as thinners, benzene, or other chemicals on or near your Chromebook



Do not place objects on top of your Chromebook.



Do not expose your Chromebook to strong magnetic or electrical fields.



Do not use or expose your Chromebook near liquids, rain, or moisture.



Do not expose your Chromebook to dusty environments.



Do not use your Chromebook near gas leaks.

### **Battery safety information**

### **Battery protection**

 Frequently charging a battery under high voltage may shorten the battery life. To protect the battery, once the battery is fully charged, the system may stop charging when the battery power is between 90% and 100%.

**NOTE:** The initiate battery power charging capacity is usually set between 90% and 99%. Actual value may vary by models.

- Charging or storing a battery in high ambient temperatures may result in permanent damage to the battery power capacity and rapidly shorten battery life. If the battery temperature is too high, the system may reduce the battery power charging capacity or even stop charging to protect the battery.
- Battery power capacity may drop even when your device is powered off and disconnected from the AC power. This is normal as the system still draws a small amount of power from the battery.

### **Standard battery care**

- If you are not using your device for a long period of time, ensure
  to charge the battery power to 50% then power off your device
  and disconnect the AC power adapter. Recharge the battery
  power to 50% every three months to avoid over-discharging and
  prevent damage to the battery. Or you may enable the long-term
  storage mode for your Chromebook in a few steps:

- Do not leave your battery in damp environments. Exposure to damp environments may increase the battery over-discharging rate. Low temperature environment may damage the chemicals inside the battery while high temperature or overheating may result in a risk of explosion.
- Do not place your device or battery pack near radiators, fireplaces, furnaces, heaters, or any sources of heat with temperature exceeding 60°C (140°F). High temperature surrounding environment may result in an explosion or leakage that may cause fire.




## Chapter 1: Hardware Setup

### **Getting to know your Chromebook**

### **Top View**

**NOTE:** The keyboard's layout may vary per region or country. The top view may also vary in appearance depending on the Chromebook model.



Array microphones

The array microphones feature echo canceling, noise suppression, and beam forming functions for better voice recognition and audio recording.

Camera

The built-in camera allows you to take pictures or record videos using your Chromebook.

Webcam shield
This allows you to cover the camera lens of your Chromebook.

Display panel

This high-definition display panel provides excellent viewing features for photos, videos, and other multimedia files on your Chromebook.

### Touch screen panel (on selected models)

This high-definition touch screen panel provides excellent viewing features for photos, videos, and other multimedia files on your Chromebook. It also allows you to operate it using touch screen gestures.

**NOTE:** For more details, refer to the *Using touch screen panel gestures* section in this manual.

### Power button

Press the power button to turn your Chromebook on or off. You can also use the power button to put your Chromebook to sleep or hibernate mode and wake it up from sleep or hibernate mode.

In the event that your Chromebook becomes unresponsive, press and hold the power button for at least four (4) seconds until your Chromebook shuts down.

### Keyboard

The keyboard provides full-sized QWERTY keys with a comfortable travel depth for typing. It also enables you to use the function keys and controls other multimedia functions.

NOTE: The keyboard layout differs by model or territory.

### Fingerprint sensor

This built-in fingerprint sensor captures your fingerprint and uses it as biometric authentication for logging on to your Chromebook's system.

### **8** Touchpad

The touchpad allows the use of multi-gestures to navigate onscreen, providing an intuitive user experience. It also simulates the functions of a regular mouse.

**NOTE:** For more details, refer to the *Using the touchpad* section in this manual.


### **Bottom View**

**NOTE:** The bottom view may vary in appearance depending on model.

**WARNING!** Your Chromebook can get warm to hot while in use or while charging the battery pack. Do not leave your Chromebook on your lap or near any part of your body to prevent injury from heat. When working on your Chromebook, do not place it on surfaces that can block the vents.

### IMPORTANT!

- Battery time varies by usage and by the specifications for this Chromebook. The battery pack cannot be disassembled.
- Purchase components from authorized retailers to ensure maximum compatibility and reliability. Consult an ASUS service center or authorized retailers for product service or assistance on proper disassembly or assembly of the product.



### Air vents

The air vents allow cool air to enter and warm air to exit the Chromebook.

**WARNING!** Ensure that paper, books, clothing, cables, or other objects do not block any of the air vents or else overheating may occur.

### Audio speakers

The built-in audio speakers allow you to hear audio straight from your Chromebook. Audio features are software-controlled.

### **Right View**




- MicroSD card slot (on selected models)

  This built in moments card reader clot supports
  - This built-in memory card reader slot supports microSD card formats.
- 2 Headphone/Headset/Microphone jack
  This port allows you to connect amplified speakers or headphones. You can also use this port to connect your headset or an external microphone.
- 3 USB 3.2 Gen 2 port
  The USB 3.2 (Universal Serial Bus 3.2) Gen 2 port provides a transfer rate of up to 10 Gbit/s and is backward compatible to USB 2.0.
- 4 Kensington® security slot

  The Kensington® security slot allows you to secure your
  Chromebook using Kensington® compatible Chromebook
  security products.

### **Left View**



### Thunderbolt™ 4 port with Power Delivery

The Thunderbolt<sup>™</sup> 4 port is compatible with USB Type-C<sup>®</sup> standards, and provides a transfer rate of up to 40 Gbit/s for Thunderbolt<sup>™</sup> 4 devices. Connect your Chromebook to a DisplayPort, VGA, DVI, or HDMI external display and experience high-resolution display features via Intel<sup>®</sup> Thunderbolt<sup>™</sup> technology. Insert the bundled power adapter into this port to charge the battery pack and supply power to your Chromebook.

**NOTE:** Transfer rate of this port may vary per model.

### IMPORTANT!

- It may take longer to fully charge your Chromebook through a low-voltage power source.
- The Thunderbolt™ 4 port with Power Delivery provides a transfer rate of up to 40 Gbit/s and is backward compatible to USB 2.0. This port supports external displays with resolutions up to 3840x2160 at 60Hz. The power output of this port is 5V/3A. The maximum power output of one single port is 5V/1.5A when both of the Thunderbolt™ 4 ports are delivering power.

HDMI output port

This port allows you to connect your Chromebook to another HDMI-compatible device for file sharing or extending your display monitor.

Two-color battery charge indicator

The two-color LED provides a visual indication of the battery's charge status. Refer to the following table for details:

Color	Status
Solid White	The Chromebook is plugged to a power source and the battery power is between 95% and 100%.
Solid Orange	The Chromebook is plugged to a power source, charging its battery, and the battery power is less than 95%.
Solid White	The Chromebook is running on battery mode.



# Chapter 2: Using your Chromebook

### **Getting started**


### **Charge your Chromebook**

- A. Connect the AC power cord to the AC/DC adapter.
- Connect the DC power connector into your Chromebook's power (DC) input port.
- C. Plug the AC power adapter into a 100V~240V power source.



Charge the Chromebook for **3 hours** before using it in battery mode for the first time.

**NOTE:** The power adapter may vary in appearance, depending on models and your region.



### IMPORTANT!

Power adapter information:

- Input voltage: 100-240Vac
- Input frequency: 50-60Hz
- Rating output current: 3A (45W)
- · Rating output voltage: 15V

### IMPORTANT!


- Locate the input/output rating label on your Chromebook and ensure that it matches the input/output rating information on your power adapter. Some Chromebook models may have multiple rating output currents based on the available SKU.
  - Ensure that your Chromebook is connected to the power adapter before turning it on for the first time. Always plug the power cord into a wall socket without using any extension cords. For your safety, connect this device to a properly grounded electrical outlet only.
  - The socket outlet must be easily accessible and near your Chromebook
  - To disconnect your Chromebook from its main power supply, unplug your Chromebook from the power socket.

### WARNING!

Read the following precautions for your Chromebook's battery:

- Only ASUS-authorized technicians should remove the battery inside the device (for non-removable battery only).
- The battery used in this device may present a risk of fire or chemical burn if removed or disassembled.
- · Follow the warning labels for your personal safety.
- · Risk of explosion if battery is replaced by an incorrect type.
- · Do not dispose of in fire.
- Never attempt to short-circuit your Chromebook's battery.
- Never attempt to disassemble and reassemble the battery (for non-removable battery only).
- · Discontinue usage if leakage is found.
- The battery and its components must be recycled or disposed of properly.
- Keep the battery and other small components away from children.

### Lift to open the display panel and your Chromebook will turn on automatically



**NOTE:** You can also press the power button to turn your Chromebook on or off.

### Gestures for the touch screen panel and touchpad

Gestures allow you to launch programs and access the settings of your Chromebook. Refer to the following illustrations when using hand gestures on your touch screen panel and touchpad.


### NOTE:

- The following screenshots are for reference only. The touch screen panel's appearance may vary depending on model.
- The touch screen panel is available on selected models.

### **Using touch screen panel gestures**

The gestures allow you to launch programs and access the settings of your Chromebook. The functions can be activated by using the hand gestures on your Chromebook's touch screen panel.

### Tap



Tap to select an item and launch it.

### **Double tap**




Double tap to select a block of text.

### Tap and hold




Tap and hold an item until a menu appears (if available), and you may tap to select an action from the menu.

### Slide to the right or left




Slide to the right or left to go backward or forward through your web browsing history.

### **Bottom edge swipe**



Slide your fingertip upward from the bottom edge of the screen to toggle on and off the auto-hide shelf

### Pinch or stretch



Use two of your fingertips to pinch or stretch on the screen to zoom out or zoom in.

### Using the touchpad

### Moving the pointer

You can tap anywhere on the touchpad to activate its pointer, then slide your finger on the touchpad to move the pointer onscreen.


### Slide horizontally



### Slide vertically




### Slide diagonally



### **One-finger gestures**

### Tap/Double-tap



- Tap an app to select it.
- Double-tap an app to launch it.
- Double-tap on an active screen to minimize or maximize it on your display panel.

### Drag and drop



Tap on an active screen then slide the same finger without lifting it off the touchpad. To drop the screen to its new location, lift your finger from the touchpad.

### **Two-finger gestures**

### Тар



Tap two fingers on the touchpad to simulate the right-click function.

Two-finger scroll (up/down)



Slide two fingers to scroll up or down.

Two-finger scroll (left/right)



Slide two fingers to scroll left or right.

### Drag and drop



Select an item then press and hold the touchpad. Using your other finger, slide on the touchpad to drag the item, lift your finger off the button to drop the item.

### **Three-finger gestures**

### Swipe left/Swipe right



If you opened multiple tabs on your web browser, swipe three fingers left or right to switch between these tabs.

### Swipe up



Swipe up to see an overview of all the screens currently opened on Chromebook.

### Using the keyboard

The following shortcut keys on your Chromebook's keyboard can be used to launch programs and functions while using your Chromebook.

←	Goes back to the previous page
C	Reloads your current web page
[3]	Activates full-screen mode for the currently opened screen
	Switches to the next window
0	Takes a screenshot

# Chapter 3: Working with Chromebook

# Starting for the first time

When you start your Chromebook for the first time, please follow the series of following steps to configure your Chromebook:

- Press the power button on your Chromebook. Wait until the setup screen appears.
- From the setup screen, select your preferred option from the drop-down button beside the following items:
  - · Select your language
  - Select your keyboard

Once finished, click/tap Let's qo.

- 3. Select a network then click/tap **Next**.
- Carefully read the Chrome OS Terms then click/tap Accept and continue.
- In the following sign-in screen, input the Email and Password of your Google account. If you don't have a Google account yet, click/tap More options > Create account.
  - If you want to skip this sign-in process, you may also click/tap **More options** > **Guest mode** to proceed.
- Once the setup process is complete, the web browser is launched and you may start working on Chromebook.

# Sign-in area

After turning on your Chromebook, the sign-in screen appears so you can choose to work on Chromebook using either of the following options:

**IMPORTANT!** Ensure you have Internet connection before choosing any of the following sign-in options.

#### **Browse as Guest**

This option is recommended if you simply want to browse online or let others use your Chromebook. Downloaded files, browser history, and cookies are not stored once you sign out as guest.

#### **User account**

Use this option to access apps and other programs offered in Chromebook and save downloaded files, apps, and browser histories right into your user account.

### Signing in to your user account

Select the user account you want to use then type your password on the **Password** field.

#### Adding a user account

Refer to the following steps if you want to add a new user account:

- 1. Click/Tap **Add Person** on the bottom part of the sign-in area.
- In the following screen, input the new Email and Password you would like to add as a user account. Your email account must be Gmail. To create a new Google account, click/tap More options > Create account.
- 3. Press Enter to continue.

# **Using your desktop**

# **Apps list**

Start working on your Chromebook by launching apps that can be accessed after signing in to your user account. These apps enable a variety of functions that can help you maximize the features of your Chromebook

To launch the apps list, click/tap on the launcher.



Apps launcher icon Launcher

#### Adding apps on the launcher

To add more apps on the launcher:

- 1. Click/Tap O.
- Right-click on the apps you want to add on the launcher then select **Pin to shelf**.


#### Deleting apps from the launcher

To delete any of the apps you currently have on the launcher:

- 1. Right-click on the apps you want to delete.
- 2. Select **Unpin**.

#### Status area


At a glance, the status area displays an overview of your Google user account information. It also allows you to change the settings of your Chromebook and your current user account.



#### Launching the status area

To launch the status area, click/tap anywhere on the status area box on the lower right corner of your desktop screen.

#### Inside the status area



- User account
  This shows the currently used Google user account.
- Network Click/Tap this option to view your current network connection, available network connections, and the network settings.
- Night Light
  Click/Tap this option to turn the night light on or off.
- 4 Volume

  Drag the volume slider to the left or to the right to turn the volume up or down on your Chromebook.

Brightness

Drag the brightness slider to the left or to the right to adjust brightness.

6 Date and time

Click/Tap this option if you want to adjust the date and time settings of your Chromebook.

Battery status

This shows the current battery life percentage of your Chromebook. It also calculates the remaining time before your battery becomes discharged or fully-charged again.

8 Sign out

Click/Tap this option to sign out from the current user account.

Shutdown

Click/Tap this option to sign out of your current log in session and turn off your Chromebook.

10 Lock

Click/Tap this option to lock your current session and return to the sign in area.

Settings

Click/Tap this option to access your Chromebook settings.

12 Bluetooth

Click/Tap this option to enable or disable your Bluetooth feature and manage other Bluetooth devices.

13 Notifications

Click/Tap this option to turn the notifications on or off.

# **Connecting to the Internet**

Internet connection is a must for you to work on Chromebook. Connect to the Internet wirelessly using a Wi-Fi connection.

# **Enabling your Wi-Fi connection**

To enable your Wi-Fi connection:

- 1. Launch the status area.
- Select No networks to automatically enable your Wi-Fi connection.

# Switching to a new Wi-Fi network connection


By default, your Chromebook uses the Wi-Fi network you chose during the setup process when you used your device for the first time. In case you need to choose a new network connection, refer to the following steps:

- Launch the status area.
- 2. Select your current Wi-Fi network connection.
- Select your new Wi-Fi network connection from the current list of networks then type in the corresponding password, if necessary.


# Adding a network connection

To add a new network connection to your list of networks:

- 1. Launch the status area.
- 2. Click/Tap 🔞.
- Under Network, select Add connection.





# **Google Cloud Print**







# **Google Drive**

There are two ways in which you can access Google Drive on your Chromebook: via the Files app or by launching the Google Drive app.

## **Launching Google Drive via the Files app**

Google Drive under the Files app allows you to see all the files that are currently stored in your Google Drive. It also allows you to quickly move files from the Downloads folder into your Google Drive.







# Tips and FAQs

# **Useful tips for your Chromebook**

To help you maximize the use of your Chromebook, maintain its system performance, and ensure all your data are kept secured, here are some useful tips that you can follow:

- Use an anti-virus software to protect your data and keep this updated too.
- Unless absolutely necessary, refrain from using force shutdown to turn off your Chromebook.
- Always backup your data and make it a point to create a backup data in an external storage drive.
- If you are not using your Chromebook for a long period of time, ensure to charge the battery power to 50% then power off your Chromebook and disconnect the AC power adapter.
- Refrain from using the Chromebook at extremely high temperatures. If you are not going to use your Chromebook for a long period of time (at least a month), we recommend that you take out the battery if the battery is removable.
- Disconnect all external devices and ensure you have the following items prior to resetting your Chromebook:
  - Backup data
  - Log in ID and password
  - Internet connection information

# **Hardware FAQs**

 A black dot, or sometimes a colored dot, appears onscreen when I turn on the Chromebook. What should I do?

Although these dots normally appear onscreen, they will not affect your system. If the incident continues and subsequently affects system performance, consult an authorized ASUS service center.

2. My display panel has an uneven color and brightness. How can I fix this?

The color and brightness of your display panel may be affected by the angle and current position of your Chromebook. The brightness and color tone of your Chromebook may also vary per model. You may use the function keys or the display settings in your operating system to adjust the appearance of your display panel.

3. How can I maximize my Chromebook's battery life?

You can try doing any of the following suggestions:

- Use the function keys to adjust the display brightness.
- Disconnect unused USB devices.
- Close unused applications, especially those that take up too much system memory.

#### 4. My battery charge indicator does not light up. What's wrong?

- Check whether the power adapter or battery pack is attached correctly. You may also disconnect the power adapter or battery pack, wait for a minute, then reconnect them again to the power outlet and Chromebook.
- If the problem still exists, contact your local ASUS service center for assistance

# 5. When I play audio and video files, why can't I hear any sound from my Chromebook's audio speakers?

You can try doing any of the following suggestions:

- Press 🔹 to turn up the speaker volume.
- Check if your speakers were set to mute.
- Check if a headphone jack is connected to your Chromebook and remove it.

#### 6. What should I do if my Chromebook's power adapter gets lost or my battery stops working?

Contact your local ASUS service center for assistance.

# 7. My Chromebook cannot do keystrokes correctly because my cursor keeps on moving. What should I do?

Make sure that nothing accidentally touches or presses on your touchpad while you type on the keyboard.

## **Software FAQs**

 When I turn on my Chromebook, the power indicator lights up but nothing appears on my screen. What can I do to fix this?

You can try doing any of the following suggestions:

- Force shutdown your Chromebook by pressing the power button for at least four (4) seconds. Check if the power adapter and battery pack are inserted correctly then turn on your Chromebook.
- If the problem still exists, contact your local ASUS service center for assistance.
- What should I do when my screen displays this message: "Remove disks or other media. Press any key to restart."?

You can try doing any of the following suggestions:

- Remove all connected USB devices then restart your Chromebook.
- Remove any optical discs that are left inside the optical drive then restart.

## 4. My Chromebook does not boot up. How can I fix this?

### 5. Why can't my Chromebook wake up from sleep mode?

- You need to press the power button to resume your last working state.

# **Appendices**

## **Internal Modem Compliancy**

The Chromebook with internal modem model complies with JATE (Japan), FCC (US, Canada, Korea, Taiwan), and CTR21. The internal modem has been approved in accordance with Council Decision 98/482/EC for pan-European single terminal connection to the public switched telephone network (PSTN). However due to differences between the individual PSTNs provided in different countries, the approval does not, of itself, give an unconditional assurance of successful operation on every PSTN network termination point. In the event of problems you should contact your equipment supplier in the first instance.

### **Overview**

On 4th August 1998 the European Council Decision regarding the CTR 21 has been published in the Official Journal of the EC. The CTR 21 applies to all non voice terminal equipment with DTMF-dialling which is intended to be connected to the analogue PSTN (Public Switched Telephone Network).

CTR 21 (Common Technical Regulation) for the attachment requirements for connection to the analogue public switched telephone networks of terminal equipment (excluding terminal equipment supporting the voice telephony justified case service) in which network addressing, if provided, is by means of dual tone multi-frequency signalling.

## **Network Compatibility Declaration**

Statement to be made by the manufacturer to the Notified Body and the vendor: "This declaration will indicate the networks with which the equipment is designed to work and any notified networks with which the equipment may have interworking difficulties."

Statement to be made by the manufacturer to the user: "This declaration will indicate the networks with which the equipment is designed to work and any notified networks with which the equipment may have inter-working difficulties. The manufacturer shall also associate a statement to make it clear where network compatibility is dependent on physical and software switch settings. It will also advise the user to contact the vendor if it is desired to use the equipment on another network."

Up to now the Notified Body of CETECOM issued several pan-European approvals using CTR 21. The results are Europe's first modems which do not require regulatory approvals in each individual European country.

## **Non-Voice Equipment**

Answering machines and loud-speaking telephones can be eligible as well as modems, fax machines, auto-dialers and alarm systems. Equipment in which the end-to-end quality of speech is controlled by regulations (e.g. handset telephones and in some countries also cordless telephones) is excluded.
