

Care & Cleaning



To assemble the monitor


- 1. Place the display on a cloth on the table, Then attach the base to the arm and fix with the screw to join them tightly. You can easily tighten the screw by fingers.
- 2. Adjust the monitor to the angle that is most comfortable for you.



This monitor is Super-Speed USB 3.2 Gen 1 compatible (5 Gbps). The port offers Max. 65W power delivery with output voltage 5V/3A, 9V/3A, 12V/3A, 15V/3A and 20V/3.25A. Connecting the USB Type-C cable can input the DisplayPort source, output power and enable the USB Type-A ports (downstream) on the monitor. Connecting the USB Type-C to Type-A cable only enables the USB Type-A ports (downstream) on the monitor.

Installaion

- 1. Turn off your computer and unplug your computer's power cord.
- Connect the signal cable to the HDMI (optional) and /or Type C (optional) and /or DP (optional) input socket of the monitor, and the HDMI (optional) and /or Type C (optional) and /or DP (optional) output socket of the graphics card on the computer. Then tighten the thumbscrews on the signal cable connector.
- 3. To use the RJ45 port: After USB upstream connection is established between the computer and the monitor, use a RJ45 cable to connect the monitor with an AP/ router. You can now access the Internet.
- Insert the monitor power cable into the power port at the back of the monitor.
- 5. Plug the power cords of your computer and your monitor into a nearby electrical outlet.
- 6. To use the USB upstream/downstream function:
 - Upstream: Use an USB Type-C cable and plug on end of the Type-c connector
 to the monitor's USB 3.2 Gen1 Type-C port as upstream and the other
 end to your computer's USB Type-C jack. Or use an USB Type-C to
 Type-A cable and plug the Type-C connector to the the monitor's USB
 3.2 Gen1 Type-C port as upstream and the Type-A connector to your
 computer's USB Type-A jack. Make sure your computer is installed with
 the latest Windows10/Windows11 operating system.
 - Downstream: Use an USB cable to connect your device with the monitor's USB Type A jack.





1.5 Monitor introduction

1.5.1 Using the Controls button

Use the control button on the back of the monitor to adjust the image settings.



1. Menu Button/Exit OSD:

- Press this Button enter the OSD menu.
- Exit the OSD menu.
- Return to previous menu.
- Key Locked Hot key

2. Enter/Close/Return Button:

- Exit the OSD menu.
- Enter/select the icon (function) highlighted while the OSD is activated.

3. Input source hot key/Increase value:

- Add or Increase value
- · Input source hot key

4. Brightness hot key/Decrease value:

- Next Item or Decrease value
- Brightness hot key

5. Power Button:

• Power on/off monitor when monitor is power off/on.

2.1 Detaching the arm/stand (for VESA wall mount)


The detachable stand of this monitor is specially designed for VESA wall mount.

To detach the arm/stand

- Disconnect power and signal cables. Carefully put the front of the monitor face down on a clean table.
- Remove the four (4) screws securing the arm to the rear of the monitor.
- 3. Detach the stand (arm and base) from the monitor.



 We recommend that you cover the table surface with soft cloth to prevent damage to the monitor.






- The VESA wall mount kit (100 x 100 mm) is purchased separately.
- Use only the UL Listed Wall Mount Bracket with minimum weight/load 12 kg (Screw size: M4 x 8.0 mm)

2.2 Adjusting the monitor

- For optimal viewing, we recommend that you look at the full face of the monitor, then adjust the monitor to the angle that is most comfortable for you.
- Hold the stand to prevent the monitor from falling when you change its angle.
- You can adjust the monitor's angle from +35° to -5° and You can also adjust the monitor's height within +/- 13cm.Before rotating the display, lift it to the top position and then push it back to the utmost degree. Rotate clockwise or counter-clockwise until the monitor stops at ±90°.





It is normal that the monitor slightly shakes while you adjust the viewing angle.

2-2 Chapter 2: Setup

3.1 OSD (On-Screen Display) menu

3.1.1 How to reconfigure



- 1. Press the MENU button to activate the OSD menu.
- 2. Press the ▼ and ▲ buttons to toggle between options in the Menu. As you move from one icon to another, the option name is highlighted.
- 3. To select the highlighted item on the menu press the ✓ key.
- 4. Press the ▼ and ▲ buttons to select the desired parameter.

3.1.2 OSD Function Introduction

1. Splendid

This function contains eight sub-functions that you can select for your preference. Each mode has the Reset selection, allowing you to maintain your setting or return to the preset mode.



- Standard Mode: This is the best choice for document editing with SPLENDID™ Video Intelligence Technology.
- sRGB Mode: This is the best choice for viewing photos and graphics from PCs.
- Scenery Mode: This is the best choice for scenery photo displaying with SPLENDID™ Video Intelligence Technology.
- **Theater Mode**: This is the best choice for movie watching with SPLENDID[™] Video Intelligence Technology.
- Game Mode: This is the best choice for game playing with SPLENDID™ Video Intelligence Technology.
- Night View Mode: This is the best choice for playing dark-scene game or watching dark-scene movie with SPLENDID™ Video Intelligence Technology.
- **Reading Mode**: This is the best choice for book reading.
- Darkroom Mode: This is the best choice for a weak ambient light environment.



- In the Standard Mode, the Saturation, SkinTone, Sharpness, and ASCR functions are not user-configurable.
- In the sRGB, the Saturation, Color Temp., SkinTone, Sharpness, Brightness, Contrast and ASCR functions are not user-configurable.
- In the Reading Mode, the Saturation, SkinTone, ASCR, contrast, and Color Temp functions are not user-configurable.

2. EyeCare



• Blue Light Filter: In this function, you can adjust the blue light filter from 0 to max. 0: no changes; Max: The higher the level, the less blue light is scattered. When blue light filter is activated, the default settings of Standard Mode will be automatically imported. Besides maximum level, the brightness is user-configurable. Maximum is the optimized setting. It is compliance with TUV low blue light certification*. The brightness function is not user configurable.



- When the user adjusts blue light filter bar to maximum level.
- *When color augmentation is in default value (50).



Please refer to the following to alleviate eye strains:

- Users should take some time away from the display if working for long hours.
 It is advised to take short breaks (at least 5 mins) after around 1 hour of
 continuous working at the computer. Taking short and frequent breaks is more
 effective than a single longer break.
- To minimize eye strain and dryness in your eyes, users should rest the eye
 periodically by focusing on objects that are far away.
- Eye exercises can help to reduces eye strain. Repeat these exercises often. If
 eye strain continues please consult a physician. Eye exercises: (1) Repeating
 look up and down (2) Slowly roll your eyes (3) Move your eyes diagonal.
- High energy blue light may lead to eye strain and AMD (Age-Related Macular Degeneration). Blue light filter to reduce 70% (max.) harmful blue light to avoiding CVS (Computer Vision Syndrome).
- Rest Reminder: This function provides you a rest reminder according
 to how long you set for your working time. For example, a user sets 60
 minutes working time and there will be a pop up reminder appeared on
 the upper left corner of the monitor for 5 seconds. Press any key to make
 this reminder OSD disappeared.



When this function is enable, the following functions are not available:
 Splendid Demo Mode, GamePlus and QuickFit.

Color Augmentation: The adjusting range of color enhancement is from 0 to 100.



- This function is not available in sRGB mode under Splendid.
- This function is not available when Reddish or Yellowish is selected in the Skin Tone menu.

3. Color

Select the image color you like from this function.



- **Brightness**: The adjusting range is from 0 to 100.
- **Contrast**: The adjusting range is from 0 to 100.
- **Saturation**: The adjusting range is from 0 to 100.
- Color Temp.: Contains three preset color modes (Cool, Normal, Warm) and User Mode.
- Skin Tone: Contains three color modes including Reddish, Natural, and Yellowish.



In the User Mode, colors of R (Red), G (Green), and B (Blue) are userconfigurable; the adjusting range is from 0 ~ 100.

4. Image

You can adjust the image Sharpness, Trace Free, Aspect Control, VividPixel, ASCR, Adaptive-Sync from this main function.



- Sharpness: Adjusts the picture sharpness. The adjusting range is from 0 to 100.
- **Trace Free:** Speeds up the response time by Over Drive technology. The adjusting range is from lower 0 to faster 100.
- **Aspect Control**: Adjusts the aspect ratio to "Full", "4:3".
- VividPixel: ASUS Exclusive Technology that brings lifelike visuals for crystal-clear and detail-oriented enjoyment. The adjusting range is from 0 to 100.
- ASCR: Select ON or OFF to enable or disable dynamic contrast ratio function.
- Adaptive-Sync: It can allow a Adaptive-Sync supported graphics source to dynamically adjust display refresh rate based on typical content frame rates for power efficient, virtually stutter free and low-latency display update.



 Particularly, Aimpoint function is specially designed for new gamers or beginners interested in First Person Shooter (FPS) games.



3.3 Troubleshooting (FAQ)
