



# **Prepare the Site**


The installation site must meet the following requirements:

- Appropriately grounded power receptacles located within 1.8 m (6 ft.).
- A readily accessible device for disconnecting power, such as a breaker or master switch.
- Network cabling within reach.
  Up to at least of 7.6 cm (3.0 in.) on all sides, for proper
- Temperature between 0°C (32°F) and 50°C (122°F) with front-to-back airflow and 0°C (32°F) to 45°C (113°F) with back-to-front airflow; see "Operating litions" for back-to-front airflow temperature -with fluctuations of less than 10°C (18°F) per hour.



# Unpack the Box

## Install the 5520 Series

### **Two-Post Mount**


5520 Series revision AD or later can use the two-post mounting kit (XN-2P-RMKIT-005) which can be ordered separately. See the 5520 Series Hardware Installation Guide at www.extremenetworks.com/documentation for installation instructions.

#### **Four-Post Mount**

This procedure uses the four-post mounting kit (XN-4P-RMKIT-005), which is included with your switch. Attach a rack ear to one side of the switch, screwing it into the holes so

- that the flange (ear) is flush with the front of the switch. Attach the other rack ear to the other side.
- Attach the rack rails to both sides of the switch using rack screws (rack screws provided).
- 4 Attach the rack ears to the front rack posts, using the screws (rack post screws not provided)

### Install VIM or Transceiver

(Optional) Versatile Interface Modules (VIM) provide dedicated high-speed ports. The 5520 Series accommodates one VIM, using the slot on the front of the switch.

(Optional) Transceivers send and receive data over optical fiber rather than through electrical wires. Insert transceivers into any of the switch's data ports.



**Warning:** To prevent damage to the switch or VIM, the switch must be powered OFF when removing or installing a VIM.

- 1 Attach the ESD wrist strap to your wrist and connect the metal end to an appropriate ground point on the rack.
- Ensure that the switch is completely turned off.
- Unscrew the captive screws by hand to remove the VIM cover plate.
- Remove the VIM from its packaging.

  Carefully slide the VIM into the slot until it is firmly in place.
- 6 Secure the VIM using the captive screws on the cover plate.

To install a transceiver:



Note: Transceivers can be Class 1 or Class 1M laser devices.

- If applicable, remove the protective dust cover from the connector.
- Hold the transceiver so that the connector will seat properly. Carefully align the transceiver with the port slot.
- Push the transceiver into the port slot until it clicks into place.

### **Connect Power**

 $5520\ \text{Series}$  switches run on AC or DC power. Connect the switch to a primary power source.



Note: Installing the system as described in this guide meets the protective earth grounding requirements of the National Electrical Code (NEC), UL/CSA/IEC/EN 62368-1 standards. However, in some cases, it may be necessary to use an alternative grounding method. In these cases, a 14 AWG wire can be connected between the grounding lug on the chassis and a nearby building ground point.

#### Connecting to the Primary Power Source

- To attach your 5520 Series to a power source, do the following: Connect the AC power cord to the AC power input socket on the power supply and an AC power outlet
- 2 For DC powered supplies, verify that the DC circuit is de-energized and then do the following:
- a Identify the grounding stud on the DC power supply. The grounding stud is next to the DC input connector, identified by the international symbol for earth ground.
- b Using the nut and washer provided, connect the ring terminal end of the ground wire to the grounding stud on the DC power supply. Use green and yellow stranded copper wire, sized at least 14 AWG.
- Connect the other end of the ground wire to a reliable earth ground. Connect the DC power input cables to the DC input connector provided. Use copper wires rated for at least 60°C and sized between 14 AWG and 8 AWG
- e Energize the circuit. When power is connected, verify that the switch's PWR LED turns green. If the PWR LED does not turn green, refer to 5520 Hardware Installation Guide for troubleshooting information.



# **Update and Configure the**

Switch Engine is the default operating system (OS) for the 5520 Series. You can change the switch OS from the Bootloader Menu on initial activation only. See 5520 Series Hardware Installation Guide for all OS upgrade and selection procedures

To change the switch OS via the Bootloader Menu:

Connect the switch to a console with a baud rate of 115200. Once the switch is powered or reset, press the **spacebar** key within 30 seconds after seeing the "5520 Boot Menu" screen to activate the Bootloader Menu

- 3 Use the down-arrow key to select Change the switch OS to Fabric Engine, then select Enter.
- 4 The switch will install Fabric Engine, then reset.




