Under Article 33 of EU REACH Regulation (1907/2006), **HID Global** has a duty to communicate to our customers the presence of SVHCs in excess of 0.1% by weight of articles (as defined by Court of Justice of the European Union Case C-106/14) contained in our products.

HID Global has reviewed their products for the presence of the two hundred and one (201) SVHC substances on the EU SVHC Candidate List as of July 16 2019.

No SVHCs were present in product indicated above, in excess of 0.1% by weight except as noted below. This determination is based on engineering evaluation, testing, and supplier declarations and is correct to the best of **HID Global**'s knowledge.
