Cisco announces the end-of-sale and end-of-life dates for the Cisco Select 1900, 2900, 3900 Software & Components. The last day to order the affected product(s) is November 2, 2020. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin.
