ST1MP, ST3MP SHIM TAB

PRODUCT FEATURES

- Self-stick backing for easy mounting
- 1/16" thickness to make faceplates flush
- Shim tabs can be stacked to achieve desired thickness

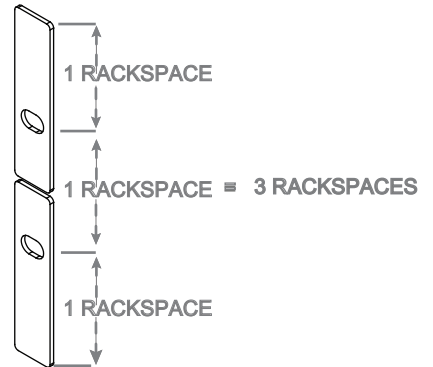
For a 1 Rackspace component
use a single ST1MP Shim Tab



For a 2 Rackspace component
use two (2) ST1MP Shim Tabs

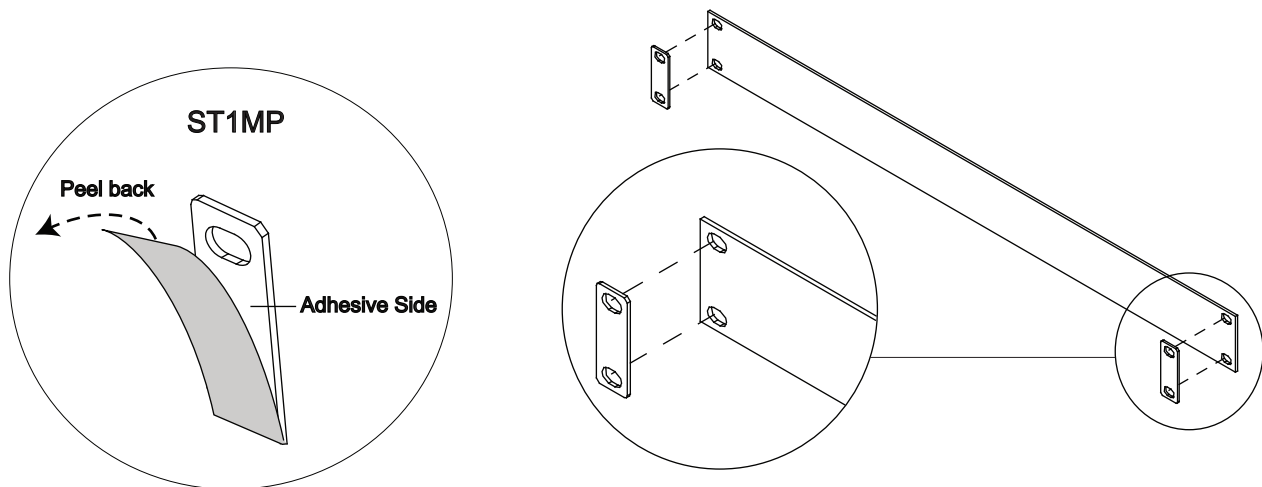


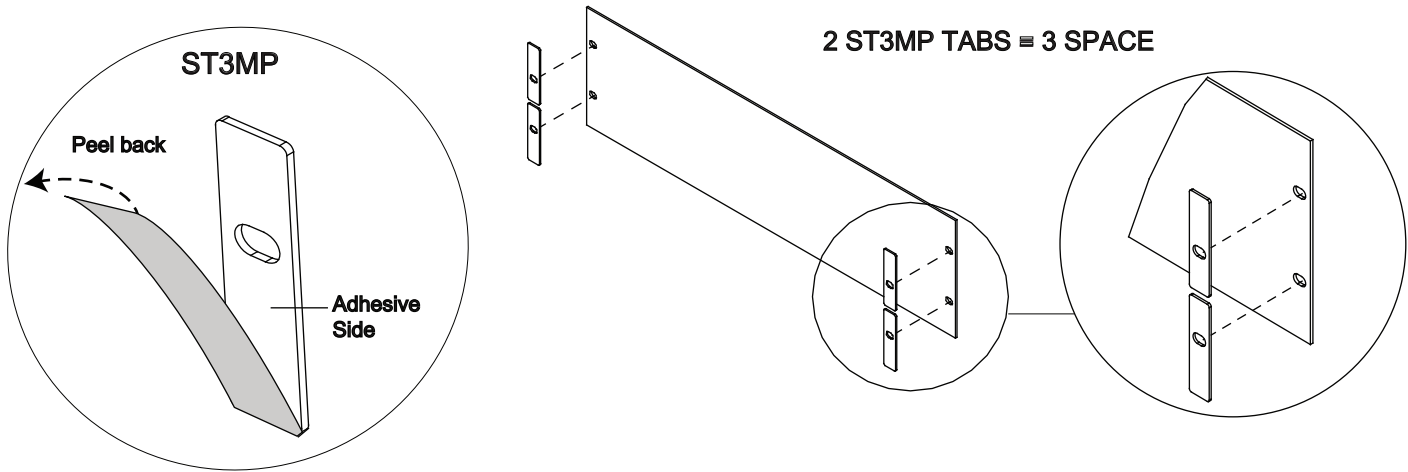
For a 3 Rackspace component
use two (2) ST3MP Shim Tabs



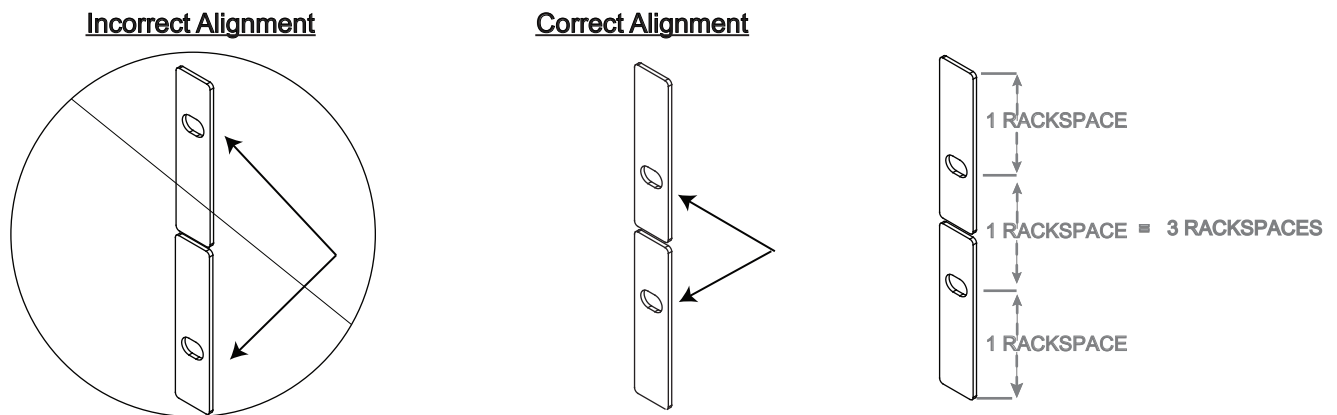
ASSEMBLY

- 1) Peel the adhesive strip back to expose the sticky side of the Shim Tab.
- 2) Attach the Shim Tab by depressing the sticky side against the inside of the component face.





NOTE: When using two (2) ST3MP Shim Tabs, ensure that the holes in the Shim Tabs align with the mounting holes on the component.
