


PRODUCT FEATURES

- Clamping design captivates the monitor even when mounted into a sloped surface




ASSEMBLY


1) Place the monitor face-down.




2) Determine which VESA bracket to use by placing bracket against back of monitor and matching hole spacing.




3) Assemble the VESA bracket as shown using the supplied hardware.
