



## INSTALLATION

## 1) Determine orientation of camera (above or below display).

2) Secure camera support brace to vertical camera mount bracket using (4) 6-32 x 3/8" screws and (4) 6-32 flange nuts (FIGURE A)





- 3) Secure horizontal camera mount bracket to vertical camera mount bracket at desired position using (2) 6-32 x 3/8" flat head screws. (FIGURE B)
- 4) Select appropriate camera base plate (8x8 or 12x8) and secure to camera support brace using (4) 10-32 flange nuts. (FIGURE B)


