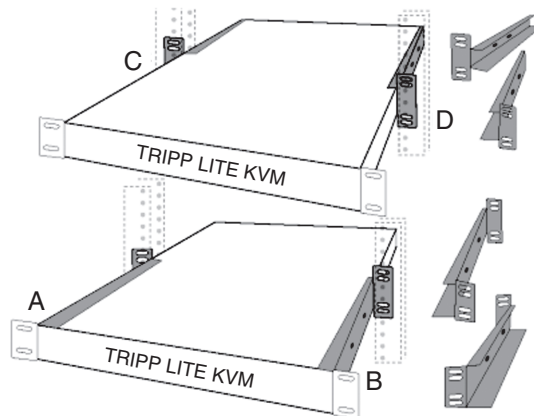
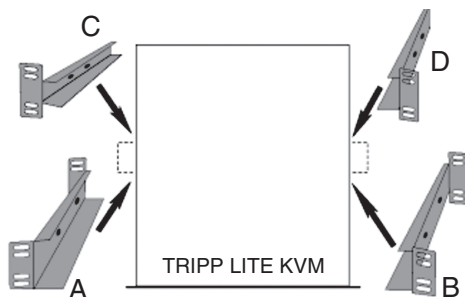

### Save These Instructions

This manual contains instructions that should be followed during installation of a Tripp Lite rackmount console KVM or rackmount console using the B019-000 2-Post Rackmount Bracket Kit. Failure to follow these instructions could result in damage to installed and connected equipment.

## Installation Instructions

1. Attach brackets A, B, C and D to the 2-post rack in the locations identified above.
2. Slide the console or console KVM into place.
3. Be sure to screw the front rackmount tabs on the console to the front tabs on brackets A and B. This will secure the console in the rack.
4. The console can be opened with the drawer either in the extended or closed position
