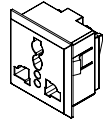

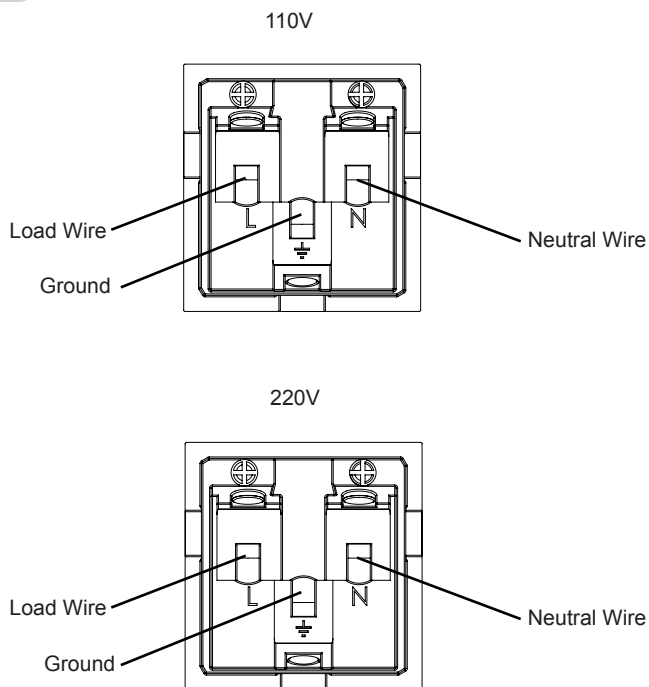
Drill the wood screws to the stud.

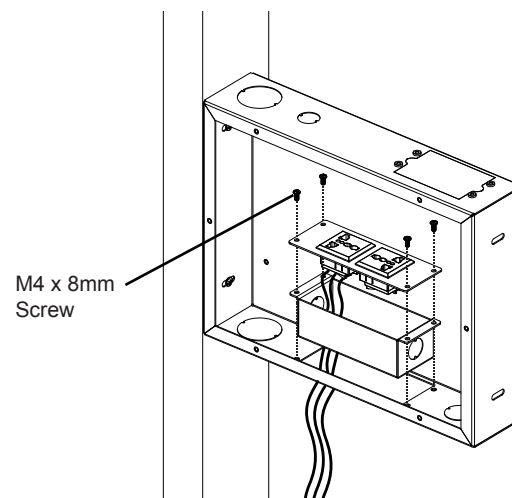


A. Media Player / Set top Box

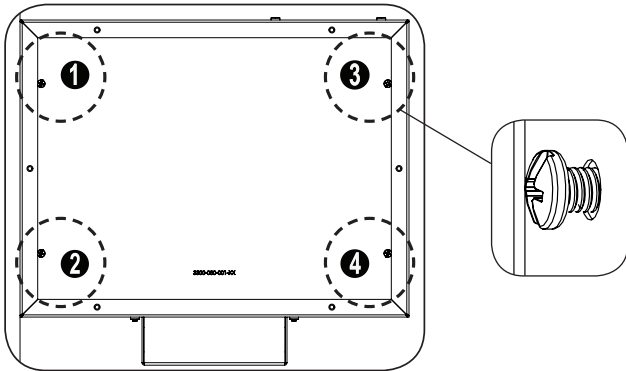


1. Put the wires up through the electrical box.

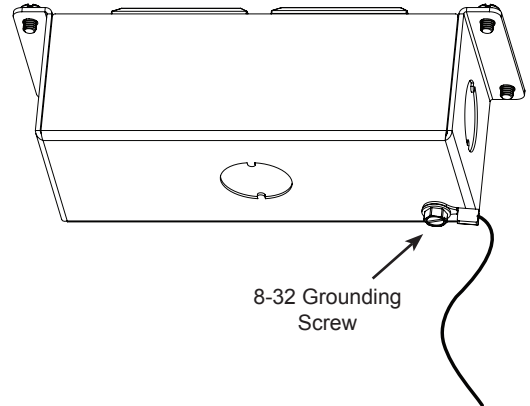

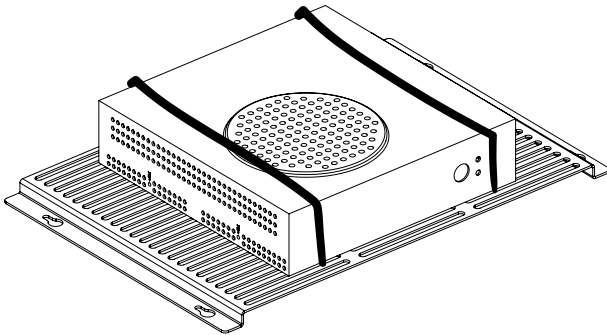
Lightly install four (4) M4 x 6mm screws inside the in-wall box.

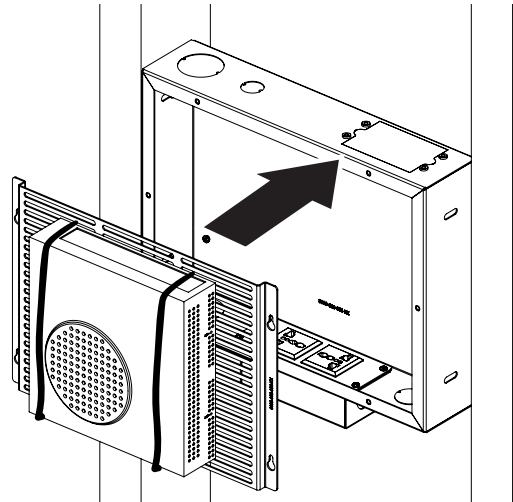
Connect the ground to the outlet box with the provided ground screw.

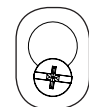


Secure the media player to the rack mount using the supplied zip ties.

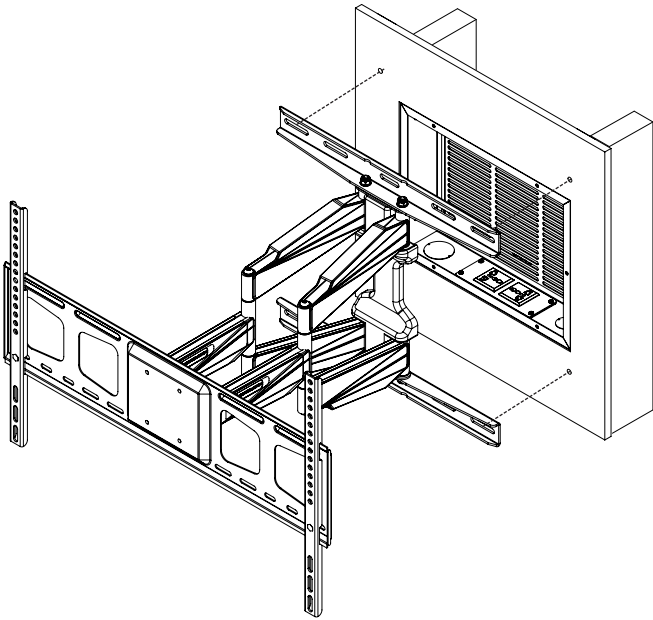


1. Insert the key slot holes onto the screws inside the in-wall box.
2. Tighten the four (4) M4 x 6 mm screws.



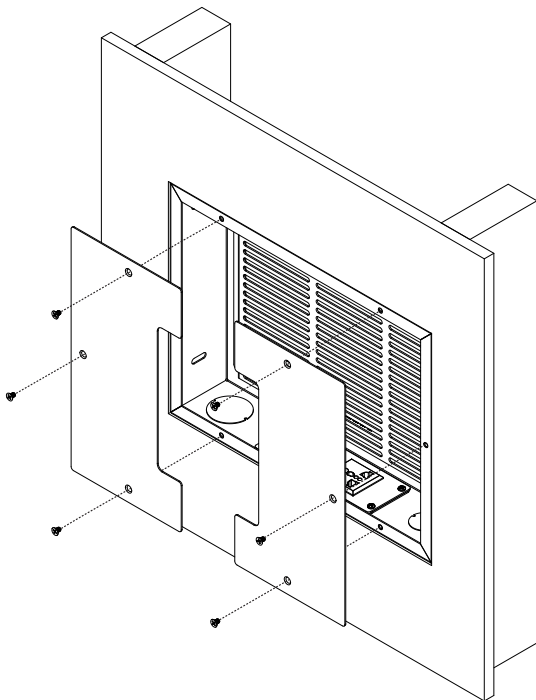

2. Refer to the AM95 installation manual to mount the AM95.

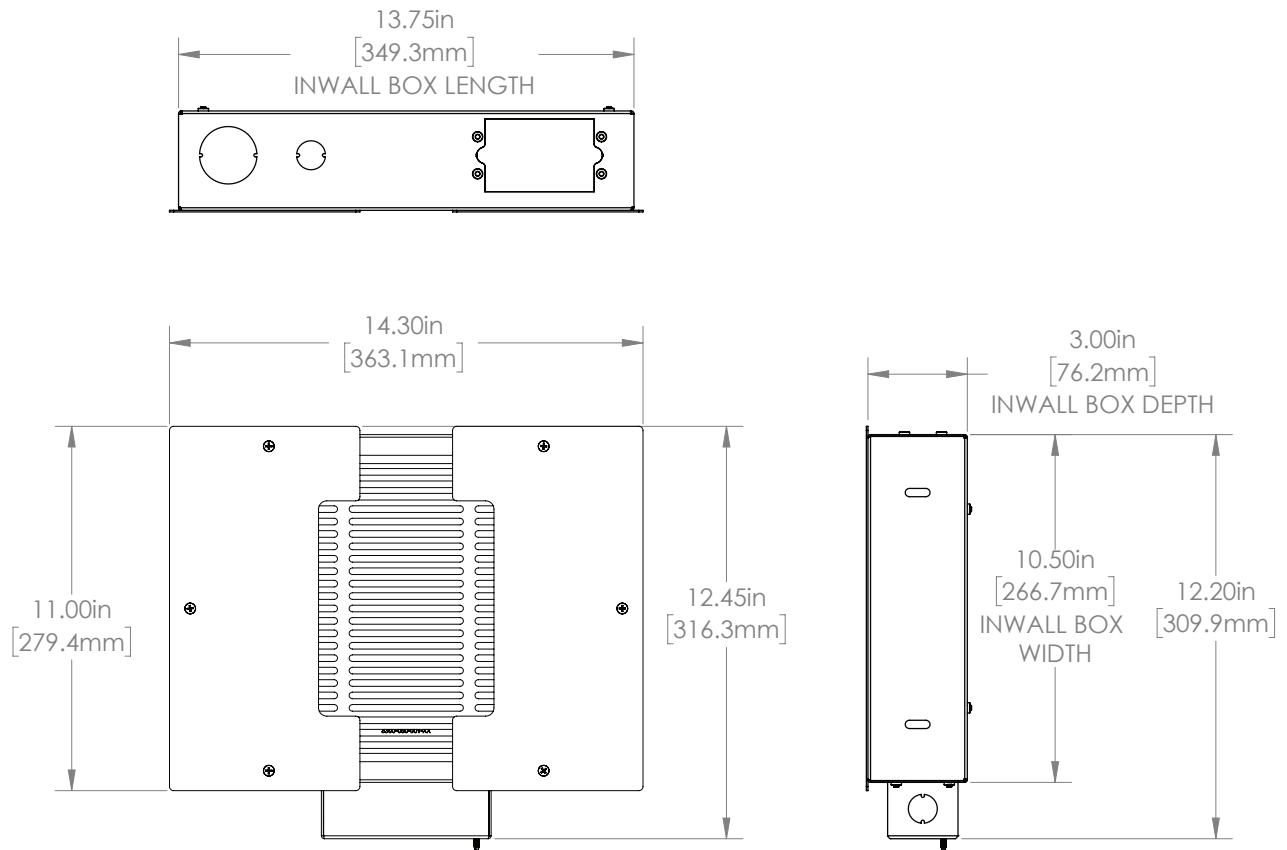
