

- RGB LED for system status







Set up procedure


1. Use an HDMI cable to connect your computer to the hub.




2. Connect the one cable to the hub.




3. Secure the one cable.




- 4. Connect desired external devices to the following connectors on the one cable:

 - Power connector



5. Secure the one cable to the bottom surface of a wooden table with the cable lock box.



6. Press the power button to turn on the hub.



Register the hub

To register the hub with Lenovo, ensure that the hub is connected to the Internet. Then, go to http:// www.lenovo.com/register and follow the instructions on the screen to enter the required information into Lenovo database.


Use ThinkSmart Manager

Chapter 5. Security

Lock the hub



Lock your hub to a desk, table, or other fixtures through a Kensington-style cable lock.

You are responsible for evaluating, selecting, and implementing the locking device and security feature. Lenovo makes no comments, judgments, or warranties about the function, quality, or performance of the locking device and security feature. You can purchase locks from Lenovo.

Use passwords

Password types

You can set the following passwords in UEFI (Unified Extensible Firmware Interface) BIOS (Basic Input/ Output System) to prevent unauthorized access to your hub. However, you are not prompted to enter any UEFI BIOS password when your hub resumes from sleep mode.

• Supervisor password

Setting a supervisor password deters unauthorized users from changing configuration settings. If you are responsible for maintaining the configuration settings of several hubs, you might want to set a supervisor password.

When a supervisor password is set, you are prompted to enter a valid password each time you try to enter the BIOS menu.

· System management password

You can enable the system management password to have the same authority as the supervisor password to control security related features. To customize the authority of the system management password through the UEFI BIOS menu:

- 1. Restart the hub. When the logo screen is displayed, press F1 or Fn+F1.
- 2. Select Security → Set System Management Password.
- 3. Follow the on-screen instructions.

If you have set both the supervisor password and the system management password, the supervisor password overrides the system management password.

Password considerations

A password can be any combination of up to 128 alphabetic and numeric characters. For security reasons, it is recommended to use a strong password that cannot be easily compromised.

Note: The BIOS passwords are not case sensitive.

To set a strong password, consider the following guidelines:

- Have at least eight characters in length
- Contain at least one alphabetic character and one numeric character
- Not be your name or your user name
- Not be a common word or a common name
- Be significantly different from your previous passwords

Set, change, and remove a password

Before you start, print these instructions.

- 1. Restart the hub. When the logo screen is displayed, press F1 or Fn+F1.
- 2. Select **Security**.
- 3. Depending on the password type, select Set Supervisor Password or Set System Management Password and press Enter.
- 4. Follow the on-screen instructions to set, change, or remove a password.

Note: A password can be any combination of up to 128 alphabetic and numeric characters. For more information, see "Password considerations" on page 14.

5. Press F10 or Fn+F10 to save the changes and exit.

Chapter 6. UEFI BIOS

This chapter provides information about configuring and updating UEFI BIOS, and clearing CMOS.

What is UEFI BIOS

Note: The operating system settings might override any similar settings in UEFI BIOS.

UEFI BIOS is the first program that the hub runs when the hub is turned on. UEFI BIOS initializes the hardware components and loads the operating system and other programs. Your hub comes with a setup program with which you can change UEFI BIOS settings.

Enter the BIOS menu

Restart the hub. When the logo screen is displayed, press F1 or Fn+F1 to enter the BIOS menu.

Note: If you have set BIOS passwords, enter the correct passwords when prompted. You also can select **No** or press Esc to skip the password prompt and enter the BIOS menu. However, you cannot change the system configurations that are protected by passwords.

Change the display language of UEFI BIOS

UEFI BIOS supports three or four display languages: English, French, simplified Chinese, and Russian (for selected models).

To change the display language of UEFI BIOS:

- 1. Select Main → Language and press Enter.
- 2. Set the display language as desired.

Change the display mode of UEFI BIOS

You can use UEFI BIOS in the graphic mode or the text mode according to your needs.

The keys on the keyboard used to perform various tasks are displayed at the bottom of the screen. In addition to the keyboard, you also can use the mouse to make selections.

To change the display mode of UEFI BIOS:

- 1. Restart the hub. When the logo screen is displayed, press F1 or Fn+F1.
- 2. Select Main → Setup Mode Select and press Enter.
- 3. Set the display mode as desired.

Change the startup sequence

If the hub does not start up from a device as expected, you can change the startup device sequence permanently or select a temporary startup device.

Change the startup device sequence permanently

1. Depending on the type of the storage device, do one of the following:

- If the storage device is internal, go to step 2.
- If the storage device is a disc, ensure that the hub is on or turn on the hub. Then, insert the disc into the optical drive.
- If the storage device is an external device other than a disc, connect the storage device to the hub.
- 2. Restart the hub. When the logo screen is displayed, press F1 or Fn+F1.
- 3. Select **Startup**, and then follow the on-screen instructions to change the startup sequence.
- 4. Press F10 or Fn+F10 to save the changes and exit.

Select a temporary startup device

Note: Not all discs and storage drives are bootable.

- 1. Depending on the type of the storage device, do one of the following:
 - If the storage device is internal, go to step 2.
 - If the storage device is a disc, ensure that the hub is on or turn on the hub. Then, insert the disc into the optical drive.
 - If the storage device is an external device other than a disc, connect the storage device to the hub.
- 2. Restart the hub. When the logo screen is displayed, press F1 or Fn+F1.
- 3. Select the storage device as desired and press Enter.

If you want to change the startup device sequence permanently, select Enter Setup on Startup Device Menu and press Enter to enter the BIOS menu.

Enable or disable a device

This section provides information about how to enable or disable user access to hardware devices (such as USB connectors or storage drives).

To enable or disable a device, do the following:

- 1. Restart the hub. When the logo screen is displayed, press F1 or Fn+F1.
- Select **Devices**.
- 3. Select the device you want to enable or disable and press Enter.
- 4. Select the desired setting and press Enter.
- 5. Press F10 or Fn+F10 to save the changes and exit.

Enable or disable the configuration change detection feature

If you enable configuration change detection, when the POST detects configuration changes of some hardware devices (such as storage drives or memory modules), an error message will be displayed when you turn on the hub.

To enable or disable the configuration change detection feature:

- 1. Restart the hub. When the logo screen is displayed, press F1 or Fn+F1.
- 2. Select Security → Configuration Change Detection.
- 3. Enable or disable the feature as desired.
- 4. Press F10 or Fn+F10 to save the changes and exit.

To bypass the error message and log in to the operating system, press F2 or Fn+F2. To clear the error message, enter the BIOS menu, save and then exit.

Enable or disable the automatic power-on feature

The Automatic Power On item in UEFI BIOS provides various options for you to make your hub start up automatically.

To enable or disable the automatic power-on feature:

- 1. Restart the hub. When the logo screen is displayed, press F1 or Fn+F1.
- 2. Select **Power** → **Automatic Power On** and press Enter.
- 3. Select the feature as desired and press Enter.
- 4. Enable or disable the feature as desired.
- 5. Press F10 or Fn+F10 to save the changes and exit.

Enable or disable the ErP LPS compliance mode

The hub meets the eco-design requirements of the ErP Lot 26 regulation. For more information, go to: https://www.lenovo.com/us/en/compliance/eco-declaration

You can enable the ErP LPS compliance mode to reduce the consumption of electricity when the hub is off or in sleep mode.

To enable or disable the ErP LPS compliance mode:

- 1. Restart the hub. When the logo screen is displayed, press F1 or Fn+F1.
- 2. Select Power → Enhanced Power Saving Mode and press Enter.
- 3. Depending on whether you select **Enabled** or **Disabled**, do one of the following:
 - If you select **Enabled**, press Enter. Then, select **Power → Automatic Power On** and press Enter. Check whether the Wake on LAN feature is disabled automatically. If no, disable it.
 - If you select **Disabled**, press Enter. Then, go to the next step.
- 4. Press F10 or Fn+F10 to save the changes and exit.

When the ErP LPS compliance mode is enabled, you can wake up the hub by doing one of the following:

- Press the power button.
- Enable the Wake Up on Alarm feature to make the hub wake up at a set time.

Change the ICE performance mode

You can adjust the acoustic and thermal performance of your hub by changing the ICE performance mode.

To change the ICE performance mode:

- 1. Restart the hub. When the logo screen is displayed, press F1 or Fn+F1.
- 2. Select Power → Intelligent Cooling Engine (ICE) and press Enter.
- 3. Select ICE Performance Mode and press Enter.
- 4. Set the ICE performance mode as desired.
- 5. Press F10 or Fn+F10 to save the changes and exit.

Exit the BIOS menu

To exit the BIOS menu, do one of the following:

• If you want to save the new settings, press the F10 key. Then, select Yes in the window displayed and press Enter.

Note: For some keyboards, you might need to press Fn+F10 to exit the BIOS menu.

 If you do not want to save the new settings, select Exit → Discard Changes and Exit and press Enter. Then, select **Yes** in the window displayed and press Enter.

Update UEFI BIOS

When you install a new program, device driver, or hardware component, you might need to update UEFI BIOS. You can update the BIOS from your operating system or a flash update disc (supported only on selected models).

Download and install the latest UEFI BIOS update package:

- 1. Go to https://smartsupport.lenovo.com/.
- 2. Download the flash BIOS update driver for the operating system version or the ISO image version (used to create a flash update disc). Then, download the installation instructions for the flash BIOS update driver you have downloaded.
- 3. Print the installation instructions and follow the instructions to update the BIOS.

Recover from a BIOS update failure

- 1. Remove all media from the drives and turn off all connected devices.
- 2. Insert the BIOS update disc into the optical drive, and then turn off the hub.
- 3. Disconnect the power cord from electrical outlet. Then, remove any parts that impede access to the Clear CMOS /Recovery jumper.
- 4. Move the jumper from the standard position to the maintenance position.
- 5. Reconnect the power cord for the hub to electrical outlet.
- 6. Turn on the hub. Wait a few minutes. The recovery process begins.
- 7. After the recovery process is completed, the hub will be turned off automatically.

Note: The recovery process will take two to three minutes.

- 8. Disconnect the power cord from electrical outlet.
- 9. Move the jumper back to the standard position.
- 10. Reinstall all the parts that have been removed. Then, reconnect the power cord for the hub to electrical outlet.
- 11. Turn on the hub. When the logo screen is displayed, press F1 or Fn+F1.
- 12. To prevent data loss, ensure that BIOS settings are restored to an earlier point. For BIOS configurations, see Chapter 6 "UEFI BIOS" on page 15.

Chapter 7. Troubleshooting, diagnostics, and recovery

This chapter provides solutions to resolve hub problems. Use the basic procedure as a starting point for resolving hub problems.

Basic procedure for resolving hub problems

Prerequisite

Before you start, read Appendix A "Important safety information" on page 33 and print the following instructions.

- 1. Check that:
 - a. The cables for all connected devices are connected correctly and securely.
 - b. All components have been reassembled correctly.
 - All connected devices that require ac power are connected to properly grounded and working electrical outlets.
 - d. All connected devices are enabled in UEFI BIOS.
- 2. See Chapter 7 "Troubleshooting, diagnostics, and recovery" on page 19 to resolve the problem you are experiencing, run the diagnostic program, and recover your operating system.
- 3. If the problem persists, contact Lenovo. See Chapter 8 "Help and support" on page 29.

How to use dual-display, content camera, or any other features in Microsoft Teams Rooms?

How to go back to Windows administrator account from Microsoft Team Rooms?

- 1. From the main menu, click the Settings icon (3) and type your password.
- 2. Click **Windows Settings** → **Administrator**, then follow the on-screen instructions to enter the Windows administrator password.

How to go back to Windows administrator account from Zoom Rooms System?

- 1. From the main menu, click **Settings** → **Room** → **Windows Settings**.
- 2. Type your password and click **Continue**. Select **ZoomRoomsAdmin**, then follow the on-screen instructions to enter the Windows administrator password.

Troubleshooting

Use the troubleshooting information to find solutions to problems that have definite symptoms.

Startup and shutdown problems

Problem	Solution
The hub does not start up when you press the power button.	Ensure that the hub is correctly connected to power through power adapter and power cord.
	 The hub voltage matches the voltage available at the electrical outlet for your country or region.
The hub cannot be shut down from the operating system.	Press and hold the power button for at least four seconds to turn it off.

Microsoft Teams Rooms problems

Problem	Solution
Microsoft Teams Rooms cannot be logged in.	Ensure that the account and password are correct and valid.
	 Ensure that the hub is connected to a wired network and is connected to your Office 365 account or your Skype for Business serve (depends on your company's deployment).
	 If the hub is connected to the Office 365 account, ensure that the account is not running in China.
The camera cannot be turned on in a meeting.	Ensure that the account has been granted the authority to use the camera.
	 Ensure that the camera can work in administrator account with "Camera" application.
	Ensure that the camera is not configured as content camera.
The calendar is not displayed.	Ensure that the account has been granted the authority to receive meeting invitations automatically.
	Check the calendar with Outlook or Office 365 Web site.

Zoom Rooms System problems

Problem	Solution
Zoom Rooms System cannot be logged in.	Ensure that the hub is connected to a wired network.
Initial signing in is not successful.	 Reset your password at <u>zoom.us/forgot_password</u>. Contact the administrator of your company to gain access.
After signing in, no room names are available to select.	Only dedicated users for managing Zoom Rooms can see the list of room names. Contact the administrator of your company to gain access.
Wrong room name is displayed.	 Click Settings → Sign Out. Enter the password (default password is 00000). Sign in again and select the correct room name.

Screen problems

Problem	Solution
The career goes black while the bulk is as	 The hub voltage matches the voltage available at the electrical outlet for your country or region.
The screen goes blank while the hub is on.	Tap the screen to wake the hub.
	The brightness and contrast is set correctly.
The image appears to be flickering.	The screen might be affected by interference from nearby equipment. Magnetic fields around other devices, such as transformers, appliances, fluorescent lights, and other monitors, might be causing the problem. Move fluorescent desk lighting or any equipment that produces magnetic fields farther away from the screen. If the problem persists, turn off the hub. Then, adjust the placement of the hub and other devices so that they are at least 305 mm (12 inches) apart. Turn on the hub.
	Reset the refresh rate.
	1. Right-click a blank area on the desktop.
	 Click Display settings. On the Display tab, click Advanced display settings → Display adapter properties for Display 1.
	Click the Monitor tab, and then reset the refresh rate to be the highest and noninterlaced.
The image is discolored.	The screen might be affected by interference from nearby equipment. Move fluorescent desk lighting or any equipment that produces magnetic fields farther away from the screen.
	 Turn off the hub. Then, adjust the placement of the hub and other devices so that they are at least 305 mm (12 inches) apart. Turn on the hub.

Audio problems

Problem	Solution
	 If you are using powered external speakers that have an On/Off control, ensure that:
	 The On/Off control is set to the On position.
	 The speaker power cable is connected to a properly grounded, functional ac electrical outlet.
The audio cannot be heard on the Windows operating system.	 If your external speakers have a volume control, ensure that the volume is not set too low.
	 Click the volume icon in the Windows notification area on the taskbar. Check the speaker and volume settings. Do not mute the speaker or set the volume at a very low level.
	 Ensure that your external speakers (and headphones, if used) are connected to the correct audio connector on the hub. Most speaker cables are color-coded to match the audio connector.
	Note: When external-speaker or headphone cables are connected to the audio connector, the internal speaker, if present, is disabled. In most cases, if an audio adapter is installed in one of the expansion slots, the audio function built into the system board is disabled. Therefore, you must use the audio connectors on the audio adapter.
	 Ensure that the audio device is configured as default speaker.
	Ensure that the audio device drivers are correctly installed.
The sound does not come from the headset or headphones.	Select the headset or headphones as the default audio output device in settings.

Storage drive problems

Problem	Solution
	 Ensure that all storage drive signal cables and power cables are connected correctly.
"No Operating System Found" message or the system not starting up from the correct storage drive.	 Ensure that the storage drive the hub starts up from is listed as the first startup device in the UEFI BIOS. Refer to "Change the startup sequence" on page 15.
	Note: In rare cases, the storage drive with the operating system might get corrupted or damaged. In such cases, you might need to replace the storage drive.

External monitor problems

Problem	Solution
An external monitor screen is blank while the monitor is connected to the hub.	 Ensure that the HDMI cable is connected to the hub and the monitor correctly and securely.
	Select HDMI signals in the signal source setting of the monitor.
	Restart the monitor.
	Change the HDMI cable.
	Reset the screen resolution.

Windows automatic recovery

Note: Ensure that your hub is connected to ac power during the recovery process.

The Windows recovery environment on your hub operates independently from the Windows 10 operating system. It enables you to recover or repair the operating system even if the Windows 10 operating system fails to start.

After two consecutive failed boot attempts, the Windows recovery environment starts automatically. Then, you can choose repair and recovery options by following the on-screen instructions.

Create and use a recovery USB device

It is recommended that you create a recovery USB drive as early as possible as a backup for the Windows recovery programs. With the recovery USB drive, you can troubleshoot and fix the problems even if the preinstalled Windows recovery programs are damaged. If you did not create a recovery USB drive as a precautionary measure, you can contact Lenovo Customer Support Center and purchase one from Lenovo. Create a recovery USB drive

- 2. Prepare a USB drive with capacity of at least 16 GB. The actual USB capacity required depends on the size of the recovery image.
- 3. Connect the prepared USB drive to the hub.
- 4. Type recovery in the search box. Then, click Create a recovery drive.
- 5. Click Yes in the User Account Control window to allow the Recovery Media Creator program to start.
- 6. In the Recovery Drive window, follow the on-screen instructions to create a recovery USB drive.

Use the recovery USB drive

If your hub cannot be started, go to Chapter 8 "Help and support" on page 29 first to try to solve the problem by yourself. If the problem persists, use the recovery USB drive to recover your hub.

- 1. Ensure that your hub is connected to ac power.
- 2. Connect the recovery USB drive to the hub.
- 3. Turn on or restart the hub. When the logo screen is displayed, press F12. The Boot Menu window opens.
- 4. Select the recovery USB drive as the boot device.
- 5. Click **Troubleshoot** to display optional recovery solutions.

6. Select a recovery solution as desired. Then, follow the on-screen instructions to complete the process.

Update the device driver

Attention: Reinstalling device drivers will change the current configuration of the hub.



Customer safety is important. Our products are developed to be safe and effective. However, personal hubs are electronic devices. Power cords, power adapters, and other features can create potential safety risks that can result in physical injury or property damage, especially if misused. To reduce these risks, follow the instructions included with your product, observe all warnings on the product and in the operating instructions, and review the information included in this document carefully. By carefully following the information contained in this document and provided with your product, you can help protect yourself from hazards and create a safer hub work environment. If the hub is used in a manner not specified by the manufacturer, the protection provided by the hub may be impaired.

Note: This information includes references to power adapters and batteries. In addition, some products (such as speakers and monitors) ship with external power adapters. If you have such a product, this information applies to your product. In addition, hub products contain a coin-sized internal battery that provides power to the system clock even when the hub is unplugged, so the battery safety information applies to all hub products.

Conditions that require immediate action

Products can become damaged due to misuse or neglect. Some product damage is serious enough that the product should not be used again until it has been inspected and, if necessary, repaired by an authorized servicer.

As with any electronic device, pay close attention to the product when it is turned on.

On very rare occasions, you might notice an odor or see a puff of smoke or sparks vent from your product. You might also hear sounds like popping, cracking, or hissing. Sharp Edges:

Power cords and power adapters



Use only the power cords and power adapters supplied by the product manufacturer.

Do not bend or modify the plug. If the plug is damaged, contact the manufacturer to obtain a replacement.

Do not share an electrical outlet with other home or commercial appliances that draw large amounts of electricity; otherwise, unstable voltage might damage your hub, data, or attached devices.

Some products are equipped with a three-pronged plug. This plug fits only into a grounded electrical outlet. This is a safety feature. Do not defeat this safety feature by trying to insert it into a non-grounded outlet. If you cannot insert the plug into the outlet, contact an electrician for an approved outlet adapter or to replace the outlet with one that enables this safety feature. Never overload an electrical outlet. The overall system load should not exceed 80 percent of the branch circuit rating. Heat and product ventilation



hubs, power adapters, and many accessories can generate heat when turned on and when batteries are charging. Always follow these basic precautions:

• Do not leave your hub, power adapter, or accessories in contact with your lap or any part of your body for an extended period when the products are functioning or when the battery is charging. Your hub, power

adapter, and many accessories produce some heat during normal operation. Extended contact with the body could cause discomfort or, potentially, a skin burn.

- Do not charge the battery or operate your hub, power adapter, or accessories near flammable materials or in explosive environments.
- Ventilation slots, fans, and heat sinks are provided with the product for safety, comfort, and reliable
 operation. These features might inadvertently become blocked by placing the product on a bed, sofa,
 carpet, or other flexible surface. Never block, cover, or disable these features.

Inspect your desktop hub for dust accumulation at least once every three months. Before inspecting your hub, turn off the power and unplug the hub's power cord from the electrical outlet; then remove any dust from vents and perforations in the bezel. If you notice external dust accumulation, then examine and remove dust from the inside of the hub including heat sink inlet fins, power supply vents, and fans. For your safety and to maintain optimum hub performance, always follow these basic precautions with your desktop hub:

- Keep the cover closed whenever the hub is plugged in.
- Regularly inspect the outside of the hub for dust accumulation.
- Remove dust from vents and any perforations in the bezel. More frequent cleanings might be required for hubs in dusty or high-traffic areas.
- Do not restrict or block any ventilation openings.
- Do not store or operate your hub inside furniture, as this might increase the risk of overheating.
- Airflow temperatures into the hub should not exceed 35°C (95°F).
- Do not install air filtration devices. They may interfere with proper cooling.

- Keep electrical appliances such as an electric fan, radio, high-powered speakers, air conditioner, and
 microwave oven away from your hub because the strong magnetic fields generated by these appliances

Clean the hub screen: Scratches, oil, dust, chemicals, and ultraviolet light can affect the performance of your hub screen. Use a dry, soft lint-free cloth to wipe the screen gently. If you see a scratchlike mark on your screen, it might be a stain. Wipe or dust the stain gently with a soft, dry cloth. If the stain remains, moisten a soft, lint-free cloth with water or eyeglass cleaner, but do not apply liquids directly to your hub screen. Ensure that the hub screen is dry before closing it.
