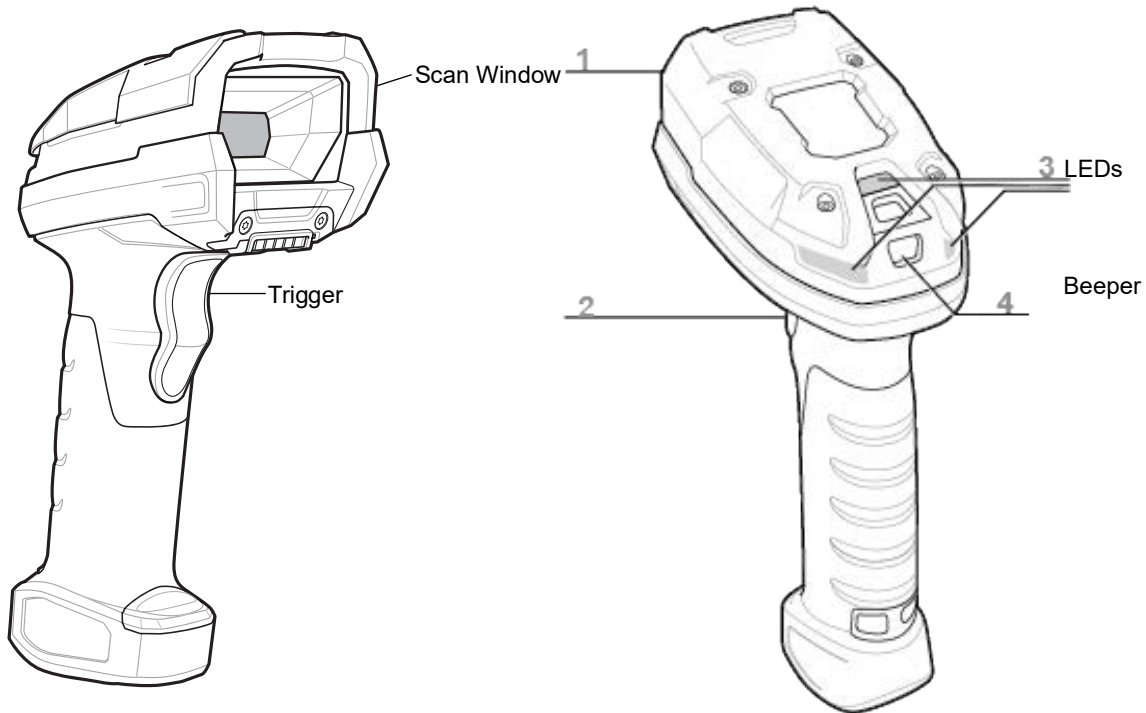

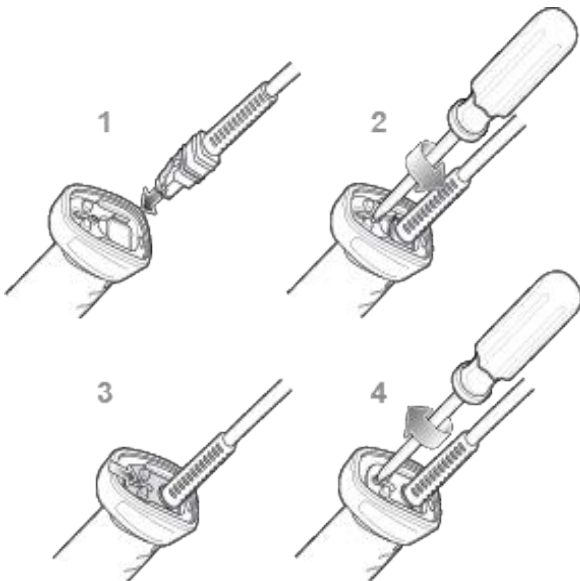

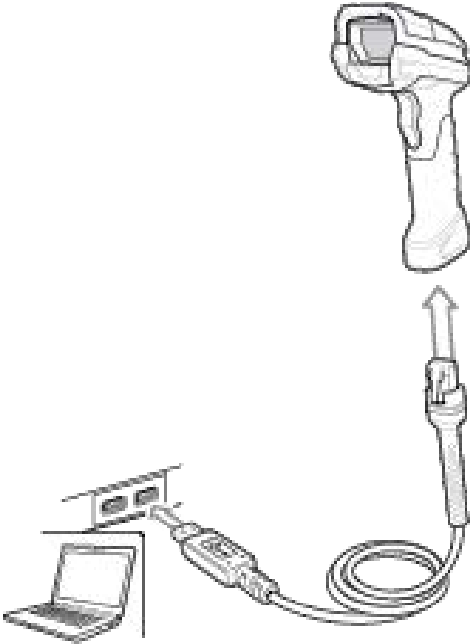
Cable Attachment

1. Insert cable fully so that the connector is flush with the scanner surface.
2. Loosen metal lock plate screws using a PH1 driver.
3. Slide lock plate to fully locked position.
4. Tighten screw using a PH1 driver, and torque to 5.8 kgf-cm (5.0 lbf-in).

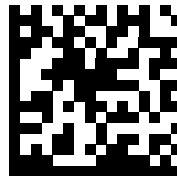

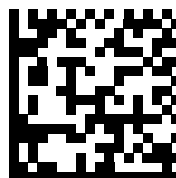

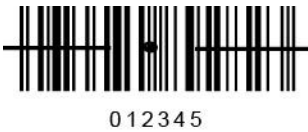

Troubleshooting

	Bar code unreadable.	Ensure bar code is not defaced; try scanning test bar code of same bar code type.
	Distance between scanner and bar code incorrect.	Move scanner closer to, or further from bar code.
Scanned data incorrectly displayed on host.	Host interface not configured properly.	Scan appropriate host parameter bar codes.
	Region improperly configured.	Select appropriate country and language encoding scheme.

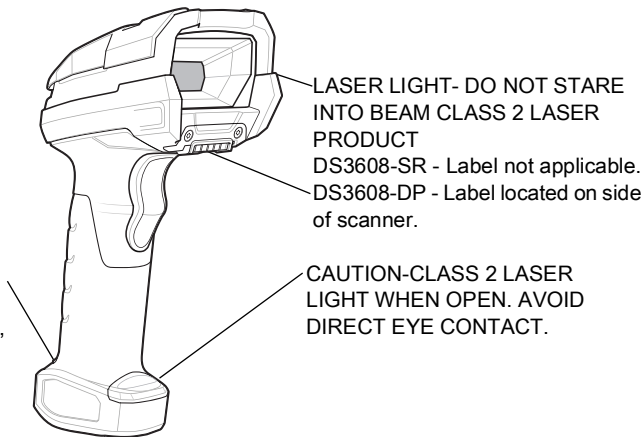
