4. First aid measures

Description of necessary first aid measures

5. Fire-fighting measures

Extinguishing media

Suitable extinguishing media : Use an extinguishing agent suitable for the surrounding fire.

Specific hazards arising from the chemical : Extremely flammable aerosol. Runoff to sewer may create fire or explosion hazard. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

In the case of aerosols being ruptured, care should be taken due to the rapid escape of the pressurized contents and propellant. 6. Accidental release measures
