mg/m3). In normal conditions of use (in electro-photographic apparatus), the maximum concentration of toner released is significantly lower than 1 mg/m3, and will have no chronic effects to human health. In cases where this product is used in bulk for purpose such as filling, cleaning, etc. of the apparatus, exposure should be controlled with care according to Sections 7

and 8.
